### REPORT OF THE MEDIA AND COMMUNICATIONS COMMITTEE TO THE SECRETARIAT

The Media and Communications Committee had its first meeting attended by a spread of eight Political Parties. It has identified press accreditation, climate creating, media venues, press kits and other logistics and liaison functions as the areas requiring focus. On the recommendation of the Managing Secretariat, Colin Coleman has been appointed Manager of this Committee working in liaison with its convenors, Saki Macazuma and Piet Coetzer. A team of five core staff is assisting him in implementation of decisions and in liaison with members of the Committee who have volunteered to oversee specific focus areas.

The Committee had some discussion on the scope of its work and decided that in the course of performing its tasks should any policy decisions be required these would be referred to the appropriate bodies by the convenors assisted by the manager.

Effort is being made to broaden the involvement by political parties in performing the tasks of this Committee both in the lead-up to and including CODESA 1 itself.

It is proposed that daily press briefings be held from Tuesday onwards. The issue of spokesperson(s) needs to be resolved.

Note should be taken that subject to a press pool for photographers, no media representatives will be present on the convention floor. Instead a gallery at the upper level to observe the proceedings is being arranged. Television coverage of the proceedings will also transmitted to the press room via SABC live coverage of CODESA.

\* The committee has all protocol issues under control, but requires clarification on the following issues:

1) Protocol services are being provided to the five international observer organisations, the Heads of accredited missions in South Africa, and what we have described as local dignataries. We are identifying the local dignataries as high-profile functionaries [ie. Chief Justice, Religious leaders, the chairmen], as well as the head of each participating delegation. If there are other individuals you feel should receive protocol treatment please inform us.

2) We are placing 2 protocol officers with each of the 5 international observer delegations. We would like to appoint these people from the organisations participating in the Protocol Sub-committee. If you feel that these officers should be appointed by yourselves, or any other body, please inform us. We need to make these appointments by Monday morning.

3) Can these 10 protocol officers also act as runners for the international observer delegations during the Conference?

4) We would like to suggest that the two co-chairmen of Codesa be asked to make themselves available to meet the Heads of the 5 international observer delegations at the airport, or that local dignataries be proposed to perform this role.

5) If any of the five international delegations require translators, can they bring them into the Conference area?

6) The ambassadors of the TBVC states have been invited to attend the Conference as observers, in addition to their participating delegations. The SACP and the ANC representatives on the Protocol committee would like clarification of this, and suggested action [ie. that the invitations are honoured or that it is suggested that the ambassadors do not attend the Conference.

8) We require clarification on the status of the Zulu king, ie. whether he will be attending with a delegation of his own [as distinct from the IFP], or as an observer, or as part of the IFP delegation?

## HOW DOES CFT ACCOMPLISH ITS AIMS?

1. A regular newsletter is sent to all members to expose the forces that attack the principles of our faith, eg. abortion, pornography, intimidation etc. Information submitted by CFT members, their problems, their victories etc. makes up the bulk of the newsletters.

2. If a CFT member has a problem with an organization or individuals intimidating him to act against his conscience  $C^{-T}$  counsels and prays with the person and then tries to contact the offending person or group.

3. CFT members may write, phone or fax to give us information or ask for prayer and advice. A head office at Kranskop has been established for this purpose.

4. A printing press has been loaned to CFT. Newsletters and booklets are printed in order to spread information.

5. In order to assist those who never had the opportunity to go to school, CFT sponsors an Adult Literacy School. Within 3 months students learn to read and write with a proficiency of standard 4 (grade 6). There are approximately 100 students at a time. Once literacy is successful in the student's home language a further course in English literacy is offered.

# WHAT SUCCESSES HAS CFT HAD?

1. A growing membership of over 1000 per month demonstrates the enthusiasm for CFT.

2. Christians who were suffering in isolation have been comforted by knowing that there are fellow believers who pray and work to assist them.

3. Information has been spread in the home language of the members. The newsletters appear in 9 languages.

4. By contacting organizations and individuals who attempt to intimidate Christians to comply to their wishes, pressure against CFT members is relieved.

5. Through the Adult Literacy Courses many have received certificates through Operation Upgrade. This enables them to find employment and gain a higher standard of living.

6. Mary white South African Christians have been made aware of the plight of their fellow black believers. This has made many realize the need for spiritual unity.



# PROTEST AGAINST BLASPHEMOUS PLAY

### Members of CFT from Durban area held a very successful demonstration against "Jesus Christ Superstar".

During the CFT conference some Durban members told the delegates about the blasphemous play that had already been running for some weeks in Durban. This rock opera "Jesus Christ Superstar" is a gross misrepresentation of our Lord Jesus Christ - our Saviour is depicted as a mere man with many failings, who has an affair with Mary Magdalene and who dies a confused and disillusioned man.

The conference agreed that something should be done about it and the Durban CFT sub-committee went into action.

The response from CFT members all over Natal was overwhelming. Starting with about 100 at 6:30 pm


on 18 August there were well over 300 Christians by the end of the demonstration proclaiming with banners and singing that Jesus Christ is Lord and not a 'superstar'!

Passers-by and some of those that were on the way into the Playhouse theatre to see the play joined the group. Even some policemen joined them in singing choruses!

Two newspapers wrote articles with photographs about the protest. A quote from the front page Daily News article: "Among the banners they carried was one saying the show must be banned. Others said: 'Jesus is Lord and not a Superstar' and 'We reject blasphemous plays'."

The composers of this rock opera, Andrew Lloyd Webber and Tim Rice are reported to have said: "We do not believe Jesus is God, we are showing him through the eyes of Judas and letting you see that this man is nothing more than a man."

The Natal Witness published a most revealing article on September 21. Some quotes: "Neither Steve Walsh nor Graham Weir, who alternate the role Jesus in Jesus Christ



Superstar, are Christians, but that hasn't prevented them gaining audience approval. Jesus wasn't trying to set up anything new, was the conclusion Walsh drew.... Rather he was trying to release people from their feelings of guilt and social inferiority - 'he was telling individuals that they had just as much right as any other person to be free and enjoy life...'.

The miracle accounts posed problems for both actors. 'I have a problem with any religion that needs miracles to sell it,' said Walsh. 'My personal belief is that he did \*\*\* with Mary Magdalene because I believe he was a man and men like doing things like that. I can't see getting to the age of 32

and still being a virgin'. 'It's not really important whether he \*\*\* with her or with all 12 disciples...'(Weir)".

Many CFT members have written to newspapers and the Publications Board to express their con-

cerns about the play. The response (which seems to be a similar letter to every complaint) from Government departments was very disappointing. Some excerpts: 'Christ's dignity is not impaired. The contents of the film is not contrary to the belief that He was both man and God.'

Mr P.J. Colyn, the Director-General of the Department of Home Affairs, also mentions something very significant in his letter, "Religious fiction is authorized by the Act provided it does not encroach in an offensive manner on the beliefs of a section of the population."

#### REPORT OF THE MEDIA AND COMMUNICATIONS COMMITTEE TO THE SECRETARIAT

The Media and Communications Committee had its first meeting attended by a spread of eight Political Parties. It has identified press accreditation, climate creating, media venues, press kits and other logistics and liaison functions as the areas requiring focus. On the recommendation of the Managing Secretariat, Colin Coleman has been appointed Manager of this Committee working in liaison with its convenors, Saki Macazuma and Piet Coetzer. A team of five core staff is assisting him in implementation of decisions and in liaison with members of the Committee who have volunteered to oversee specific focus areas.

The Committee had some discussion on the scope of its work and decided that in the course of performing its tasks should any policy decisions be required these would be referred to the appropriate bodies by the convenors assisted by the manager.

Effort is being made to broaden the involvement by political parties in performing the tasks of this Committee both in the lead-up to and including CODESA 1 itself.

It is proposed that daily press briefings be held from Tuesday onwards. The issue of spokesperson(s) needs to be resolved.

Note should be taken that subject to a press pool for photographers, no media representatives will be present on the convention floor. Instead a gallery at the upper level to observe the proceedings is being arranged. Television coverage of the proceedings will also transmitted to the press room via SABC live coverage of CODESA.

PROTOCOL SUB-COMMITTEE REPORT

13 DECEMBER 1991

\* Committee has established small working group which meets every second day. There is a person responsible for each of:

- Communication with observers and the facilitation of bilateral meetings

- Airport arrivals and hotel arrangements

- Transport and liaison with security

- Conference centre arrangements for VIP's [Meeting VIP's at Convention Centre, and VIP rooms and facilities]

- Banquet

\* The committee has all protocol issues under control, but requires clarification on the following issues:

1) Protocol services are being provided to the five international observer organisations, the Heads of accredited missions in South Africa, and what we have described as local dignataries. We are identifying the local dignataries as high-profile functionaries [ie. Chief Justice, Religious leaders, the chairmen], as well as the head of each participating delegation. If there are other individuals you feel should receive protocol treatment please inform us.

2) We are placing 2 protocol officers with each of the 5 international observer delegations. We would like to appoint these people from the organisations participating in the Protocol Sub-committee. If you feel that these officers should be appointed by yourselves, or any other body, please inform us. We need to make these appointments by Monday morning.

3) Can these 10 protocol officers also act as runners for the international observer delegations during the Conference?

4) We would like to suggest that the two co-chairmen of Codesa be asked to make themselves available to meet the Heads of the 5 international observer delegations at the airport, or that local dignataries be proposed to perform this role.

5) If any of the five international delegations require translators, can they bring them into the Conference area?

6) The ambassadors of the TBVC states have been invited to attend the Conference as observers, in addition to their participating delegations. The SACP and the ANC representatives on the Protocol committee would like clarification of this, and suggested action [ie. that the invitations are honoured or that it is suggested that the ambassadors do not attend the Conference.

7) The Protocol Committee would also like clarification as to why certain African countries [esp. Botswana and Namibia] have not been invited to the Conference. Is it because they do not have accredited embassies in SA or because they are represented by the OAU?

8) We require clarification on the status of the Zulu king, ie. whether he will be attending with a delegation of his own [as distinct from the IFP], or as an observer, or as part of the IFP delegation?

9) We require a recommendation from the Secretariat as to what flags and banners, if any, should be displayed at the entrance to the Convention Centre.

## HOW DOES CFT ACCOMPLISH ITS AIMS?

1. A regular newsletter is sent to all members to expose the forces that attack the principles of our faith, eg. abortion, pornography, intimidation etc. Information submitted by CFT members, their problems, their victories etc. makes up the bulk of the newsletters.

2. If a CFT member has a problem with an organization or individuals intimidating him to act against his conscience  $C^{\text{ET}}$  counsels and prays with the person and then tries to contact the offending person or group.

3. CFT members may write, phone or fax to give us information or ask for prayer and advice. A head office at Kranskop has been established for this purpose.

4. A printing press has been loaned to CFT. Newsletters and booklets are printed in order to spread information.

5. In order to assist those who never had the opportunity to go to school, CFT sponsors an Adult Literacy School. Within 3 months students learn to read and write with a proficiency of standard 4 (grade 6). There are approximately 100 students at a time. Once literacy is successful in the student's home language a further course in English literacy is offered.

### WHAT SUCCESSES HAS CFT HAD?

1. A growing membership of over 1000 per month demonstrates the enthusiasm for CFT.

-

2. Christians who were suffering in isolation have been comforted by knowing that there are fellow believers who pray and work to assist them.

3. Information has been spread in the home language of the members. The newsletters appear in 9 languages.

4. By contacting organizations and individuals who attempt to intimidate Christians to comply to their wishes, pressure against CFT members is relieved.

5. Through the Adult Literacy Courses many have received certificates through Operation Upgrade. This enables them to find employment and gain a higher standard of living.

6. Many white South African Christians have been made aware of the plight of their fellow black believers. This has made many realize the need for spiritual unity.

# PROTEST AGAINST BLASPHEMOUS PLAY

#### Members of CFT from Durban area held a very successful demonstration against "Jesus Christ Superstar".

During the CFT conference some Durban members told the delegates about the blasphemous play that had already been running for some weeks in Durban. This rock opera "Jesus Christ Superstar" is a gross misrepresentation of our Lord Jesus Christ - our Saviour is depicted as a mere man with many failings, who has an affair with Mary Magdalene and who dies a confused and disillusioned man.

The conference agreed that something should be done about it and the Durban CFT sub-committee went into action.

The response from CFT members all over Natal was overwhelming. Starting with about 100 at 6:30 pm

on 18 August there were well over 300 Christians by the end of the demonstration proclaiming with banners and singing that Jesus Christ is Lord and not a 'superstar'!

Passers-by and some of those that were on the way into the Playhouse theatre to see the play joined the group. Even some policemen joined them in singing choruses!

Two newspapers wrote articles with photographs about the protest. A quote from the front page Daily News article: "Among the banners they carried was one saying the show must be banned. Others said: 'Jesus is Lord and not a Superstar' and 'We reject blasphemous plays'."

The composers of this rock opera, Andrew Lloyd Webber and Tim Rice are reported to have said: "We do not believe Jesus is God, we are showing him through the eyes of Judas and letting you see that this man is nothing more than a man."

The Natal Witness published a most revealing article on September 21. Some quotes: "Neither Steve Walsh nor Graham Weir, who alternate the role Jesus in Jesus Christ



Superstar, are Christians, but that hasn't prevented them gaining audience approval. Jesus wasn't trying to set up anything new, was the conclusion Walsh drew.... Rather he was trying to release people from their feelings of guilt and social inferiority - 'he was telling individuals that they had just as much right as any other person to be free and enjoy life...'.

The miracle accounts posed problems for both actors. 'I have a problem with any religion that needs miracles to sell it,' said Walsh. 'My personal belief is that he did \*\*\* with Mary Magdalene because I believe he was a man and men like doing things like that. I can't see getting to the age of 32

> and still being a virgin'. 'It's not really important whether he \*\*\* with her or with all 12 disciples...'(Weir)". Many CFT members have written

> to newspapers and the Publications Board to express their con-

cerns about the play. The response (which seems to be a similar letter to every complaint) from Government departments was very disappointing. Some excerpts: 'Christ's dignity is not impaired. The contents of the film is not contrary to the belief that He was both man and God.'

Mr P.J. Colyn, the Director-General of the Department of Home Affairs, also mentions something very significant in his letter, "Religious fiction is authorized by the Act provided it does not encroach in an offensive manner on the beliefs of a section of the population."
