CONSTITUTIONAL ASSEMBLY MINUTES OF THE MANAGEMENT COMMITTEE MEETING WEDNESDAY 17 JANUARY 1996

1. OPENING

- 1.1 The Chairperson opened the meeting at 10h05.
- 1.2 The meeting noted that Mr. Gordhan would replace Mr. Moosa, Mrs. Mbete-Kgositsile would replace Mrs. Myakayaka-Manzini, and Mrs. de Lille would replace Mr. Sizani for this meeting of the Management Committee.
- 1.3 The Agenda was adopted.

2. MINUTES

The meeting adopted the Minutes of the Management Committee Meeting on Thursday 14 September 1996.

3. MATTERS ARISING

Mr. Ebrahim introduced the memorandum entitled, "Matters Arising," included in the documentation. Discussion was as follows.

3.1 COAT OF ARMS

The Chairperson recalled that each political party had been asked to

nominate one person to sit on the subcommittee that would deal with the coat of arms. The meeting agreed that the deadline for nominations would be 24 January 1996 and that the subcommittee would meet thereafter.

3.2 TEAM OF EXPERTS - NATIONAL TERRITORY

Mr. Ebrahim reported that the Administration was organising a meeting of experts to consider how to define the national territory in the new constitution, as instructed by the Constitutional Committee. The Administration would forward a report to the Management Committee in due course.

3.3 TEAM OF EXPERTS - LANGUAGE

Mr. Ebrahim reported that the Administration was looking into the question of language advisors for the new constitution, following the Constitutional Commttee's recommendation on 10 November 1995.

4. DRAFT SCHEDULE OF WORK

4.1 PROGRAMME OF WORK

- 4.1.1 Mr. Ebrahim introduced the document entitled "Draft Schedule of Work," contained in the documentation.
- 4.1.2 The meeting agreed to accept the "Draft Schedule of Work" in principle, but noted the need for flexibility, both with regard to meeting dates and times, and agenda items for discussion.
- 4.1.3 General Viljoen of the FF expressed concern that additional time was needed for parties to discuss the issue of selfdetermination. The meeting agreed to postpone the matter. The Management Committee would consider when to reschedule it during the mid-February evaluation.
- 4.1.4 Mr Meyer of the NP queried whether the CA could not meet on days other than Monday, when he had other Cabinet business scheduled. It was agreed this would be considered on an ongoing basis in keeping with the need for flexibility already agreed upon. The Chairperson noted however that due to the limited time available for completion of work, it would be necessary to utilise time set aside for CA business, including Mondays.

4.2 REVIEW OF PROCESS

- 4.2.1 The meeting agreed that the Management Committee would:
 - i. Assess progress made on an ongoing basis, and
 - ii. Conduct an initial assessement of progress on 15 February 1996.
 - iii. The Management Committee could undertake a second review a month later if necessary.
- 4.2.2 It was agreed that during the 15 February 1996 meeting the Management Committee would provide guidance on how to deal with outstanding issues and assess whether additional measures would be needed to speed up work, such as establishing a second sub-committee or requesting additional days from Parliament for Constitutional Assembly work.

4.3 ADMINISTRATION

Mr. Ebrahim noted that the Administration had gone through a process of re-organisation to deal effectively with this last phase of work.

4.4 ADOPTION OF THE CONSTITUTION

The meeting agreed that members would begin considering the programme for the day the constitution was adopted. The matter, however, would be dealt with later.

5. HEARINGS AND WORKSHOPS

- 5.1 Mr. Ebrahim introduced the documents entitled, "Major Urban Areas Association: Inputs on Local Government," "Commonwealth Secretariat, Possible Workshop on Electoral Management," and "Volkstaat Council," included in the documentation. He reported that additional proposals for hearings had been forwarded by the Public Service Commission and the French embassy.
- 5.2 The Chairperson ruled that these matters would be considered further to see how they could be accomodated in the Constitutional Assembly programme.

6. CONSTITUTIONAL COURT CERTIFICATION

6.1 Mr. Ebrahim introduced the documents entitled, "Constitutional Court

of South Africa," included in the documentation, and "Certification of the New Constitution," included in the additional documentation.

- 6.2 The meeting agreed:
 - i. The Executive Director should follow up to request an opinion on the possible consequences of a Constitutional Court decision that the new Constitution did not comply substantially with the Constitutional Principles;
 - ii. A technical team, comprising legal advisers and the Panel, should begin to consider a whole host of issues relating to certification, including the issue of transition which the Constitutional Committee had not yet begun to consider;
 - iii. A proper discussion on this matter should follow at the evaluation of the process in mid-February; and
 - iv. A briefing memorandum would be prepared for CA members after the evaluation, setting out the proposals from the Constitutional Court and also dealing with various organisational and logistical matters - such as preparation of documentation to accompany the draft, how the CA had complied with the Constitutional Principles, engaging counsel to argue the case in court, the rules of the Constitutional Court, CA Rules and compliance with the Constitution itself.

7. REPORT ON THE BUDGET

The meeting noted the document entitled, "Constitutional Budget 95/96 Update," contained in the documentation, and heartily thanked the governments of Denmark, the Netherlands, Norway, Switzerland and Sweden for their generous contributions to the Public Participation Programme and the Media Campaign.

8. **REPORT ON MEDIA**

The meeting noted the document entitled, "Media Department's Report," included in the documentation. Mr. Ebrahim reported, however, that national meetings would not be sector based, as suggested in paragraph 1(c), but issue based, as proposed in paragraph 4.

9. PUBLIC PARTICIPATION PROGRAMME

9.1 The meeting noted the document entitled, "Community Liaison Department Report to Management Committee," included in the documentation. 9.2 The meeting agreed that a schedule of Constitutional Education Programme workshops run by co-ordinators in the various provinces would be drawn up and circulated to all members,

10. LEGACY PROJECT

- 10.1 The meeting noted the document entitled, "Legacy Project," included in the documentation.
- 10.2 The meeting agreed that the matter would be dealt with at the 15 February 1996 evaluation.
- 10.3 The Chairperson ruled that a document would be prepared for consideration at the 15 February 1996 evaluation on the projected costs of popularisation.

11. AOB

The meeting agreed to cancel the Management Committee meeting scheduled for 25 January 1996. It was agreed that the Administration would notify members should it be necessary to meet on that date.

12. CLOSURE

The Chairperson closed the meeting at 11h25.
