I don't know about them. They ~~forced~~
forced me that I must say W. Tshongoyi and
G. Gogela are my leaders. I refused.

Ek ondersoek die bedrywighede van die verbode organisasie,
Pan Africanist Congress (P.A.C.), wat onder die bantoes bekend is
as POQO.

I am investigating the movements of the banned Pan
Africanist Congress, also known as POQO.

Daar is inligting tot my beskikking en ek het rede om
te glo dat jy 'n lid van hierdie verbode organisasie is. Dit is
'n ernstige saak en ek moet jou waarsku om versigtig te wees wat
jy sê. Jy is, egter, nie verplig om enigiets te sê wat jou mag in-
krimineer nie, maar wat jy sê, sal op skrif gestel word en dit
mag as getuienis gebruik word.

There are reasonable grounds for suspicion that you are
a member of this banned Organization.

This, however, is a very serious matter and I warn to you
to be careful what you say. You're not compelled to say anything
which may incriminate you, but what ever you say will be taken down,
and it may be used in evidence.

Verstaan jy wat die aard van die beweerde aanklag is en
jou regte?

Do you understand the nature of the charge, and you're
priviledges?

Yes I understand.

I am a Xosa, 26 yrs. old and
was born at Cala. I passed Std. 8 at
school.

I was arrested on 3.5.63.
at the time of my arrest I was in
the employ of J. Pelly a four - Cape Town
market.

During 1960 I was a member of
P.A.C. and I was also arrested during
that year at Woodstock. I had a P.A.C.

sample in my hand at the time of my arrest. I was charged in the Cape Town court and was sentenced to 9 months im.

Since my release I have started to work with my present employers. I live with my parents at 21 Mount St., Woodstock, Cape Town.

I was persuaded to become a member of the P.A.C. by a man known to me by the name Xintolo. He was ordered to leave Cape Town during the beginning of 1962. He was sent back to the Transvaal.

I have heard of the organisation known as Pogo.

During June, 1962 I was approached by Gogella and Wellington Tshongoyi (my uncle) to join Pogo. I refused to join.

I did not ever attend any meetings. I did not give any money for Pogo.

Should any evidence be furnished to the police that I am a member, that I attended any meetings or that I contributed money, it would be false evidence. I know nothing more about Pogo.
