## REVISED MEMORANDUM

RE: DATE FOR CODESA II

At its meeting on 2 March 1992 the DMC came to the following conclusions:

- It appears that Working Groups, while making good progress, might need a little more time for substantial breakthroughs. This might mean that to hold CODESA II later than the end of March, would be more benificial to the process.
- The DMC is therefore opening up discussion on another date for CODESA II. In this regard, the period post the Easter weekend in April has been mentioned.
- The DMC is consequently inviting all chairperson's of Working Groups as well as MC members to
  make recommendations on this matter for presentation at the next MC meeting, to reach the Secretariat
  by Friday, 6 March 1992.
