1. **Chairperson's opening remarks**

The members were welcomed. It was noted that the purpose of this meeting was to reach a decision in respect of the participation of the Zulu King and other Traditional Leaders in Codesa. The chairperson urged the members to be flexible and to try and arrive at a compromise formula in this regard.

2. **Participation of the Zulu King and other Traditional Leaders in Codesa**

- 2.1 A suggestion by INM was noted; namely that it could be helpful to decide on this issue in stages. It appeared that agreement concerning the participation for the duration of Codesa 2 by the Traditional Leaders, exists. The issue around which no agreement has yet been reached, concerns the form of participation of Traditional Leaders in Codesa.
- 2.2 It was suggested, by the IFP, that the form of participation of Traditional Leaders should be decided by the Traditional Leaders by themselves, within the four delegations.
- 2.3 After discussion and the revisitation of various arguments by the members, it was noted that no consensus or sufficient consensus could be arrived at.
- 2.4 It was agreed to explore this matter further with principals and that this issue be left open and appear on the agenda of the MC meeting of 7 May 1992 with a view to reaching a final decision.

3. **Chairperson's closing remarks**

The Chairperson closed the meeting at 19h30 with the following remarks:

- * This matter would be discussed at the next MC meeting on the basis and understanding that arguments are not to be repeated. Members are to merely indicate compromises arrived at.
- * The members were requested to consider all the compromise options.
- * A hope was expressed that consensus can be arrived at on this matter at the next MC meeting.
