**1. Opening remarks**

- 1.1 Welcome to all and welcome to Mr Fouche of the World Trade Centre.
- 1.2 Apologies from Mr LV Ntsubane.

**2. Minutes**

2.1 Ratification and adoption

All points of the minutes of the Security Sub-committee meeting held on 18 February 1992 are correct.

2.2 Matters arising

2.2.1 Firearms - Col J Venter has undertaken to speak to the Commissioner of Police. It was further agreed by Mr Shaik and Col Venter that this question should be resolved by CODESA II.

2.2.2 Stipend - All that is required is a Certificate of Service. Ground Staff will be paid R60 per day, and Supervisors R70.

This was acceptable to both Col Venter and Mr Mampane.



### 2.3 Progress report

2.3.1 Code of Conduct - The DMC has not responded to this, owing to work load. Mr Shaik has suggested that another letter be sent to them in this regard. Mr Morobe is to send such a letter through his office.

2.3.2 Combi/Transport - Col Venter and Mr Mampane were unable to meet with Mr Du Plooy. Mr Du Plooy has said that Security cannot be given a bus for its own uses and that members of Security should make use of the existing transport system.

This was unacceptable and it was requested that the matter be taken up by Mr Morobe through the Management Committee.

2.3.3 Post - The system of screening the post in the X-ray machine has only been carried out once so far and there has been no further need for it. However, this system will be used whenever necessary. Col Venter made the suggestion that staff, or anyone related to CODESA, who receive suspicious mail should not hesitate to bring it to Security for screening.

2.3.4 Letter to WTC - Mr Fouche noted that Security at side door was slack and he furthermore stated that this had also been pointed out to him by other tenants, whom he claimed were Conservative Party supporters.

Col Venter and Mr Mampane took note of Mr Fouche's complaints with regard to slackness and suggested that Supervisors be more vigilant and visit the various points more often.

It was noted with disapproval that Mr Fouche had not brought the fact that certain tenants were Conservative Party supporters to the notice of Security sooner.

It was further requested that Mr Fouche supply Cpt Pretorius with the names of the tenants who are regarded as Conservative Party supporters, so that they can be checked.

2.3.5 Letter from WTC dated 25 February 1992 - This letter was noted. The problem to which the letter was referring was however resolved, once it had been brought to the attention of the relevant people.

Strong objection to the tone of the letter was noted and Mr Morobe was requested to object officially to this.
