re: POLITICAL PRISONERS/EXILES

The members of the ex ANC detainees committee request permission to submit a written and a verbal submission to Codesa on the above matters.

Specifically we request that our grievances be addressed which are as follows:-

1. The MK claims to be a liberation army and therefore the war crimes committed by the MK must be prosecuted.
2. We have suffered as a consequence of ANC/MK actions, eg. torture, incarceration etc. The ANC/MK must pay reparations to us and to the families of those who were murdered by the ANC/MK.
3. Many of our comrades lie buried in foreign lands. We wish that the ANC/MK will bring our comrades home to rest in peace in the land of their birth.
4. We believe that the ANC/MK are still holding political prisoners outside of South Africa. The South African Government has an obligation to care for it's citizens, and we demand that those who are still held prisoner should be released. The SA Government must secure the release of all ANC political prisoners held in foreign lands, and if necessary, the assistance of the UN and the international community must be solicited to execute this task.



CODESA POLITICAL PRISONERS

WE ARE VERY GLAD TO RECEIVE A LETTER FROM YOU WHICH INFORM THE COMMITTEE TO PRESENT A VERBAL SUBMISSION AS WELL' PERTAINING THE (CODESA) BPOLITICAL PRISONERS.

WE WOULD LIKE TO BE REPRESENTED BY THE(CHAIRMAN) OF THE COMMITTEE TO ADDRESS THE CODESA GROUP 2.

WE ALSO INCLUDE THE SUBSEQUENT POINTS WHICH WOULD BE A PART OF PRESENTATION FROM THE COMMITTEE.

SPECIFICALLY WE REQUEST THAT OUR GRIEVANCES BE ADDRESSED WHICH ARE AS FOLLOWS:-

1. THE MK CLAIMS TO BE A LIBERATION ARMY AND THEREFORE THE WAR CRIMES COMMITTED BY THE MK MUST BE PROSECUTED.
2. WE HAVE SUFFERED AS A CONSEQUENCES OF A.N.C./MK. ACTIONS'eg. TORTURE' INCARCERATION etc. THE A.N.C./MK MUST PAY REPARATIONS TO US AND TO THE FAMILIES OF THOSE WHO WERE MURDERED BY THE A.N.C./MK.
3. MANY OF OUR COMRADES LIE BURIED IN FOREIGN LANDS. WE WISH THAT THE A.N.C./MK WILL BRING OUR COMRADES HOME TO REST IN PEACE IN THE LAND OF THEIR BIRTH.
4. WE BELIEVE THAT THE A.N.C./MK ARE STILL HOLDING POLITICAL PRISONERS OUTSIDE OF SOUTH AFRICA. THE SOUTH AFRICAN GOVERNMENT HAS AN OBLIGATION TO CALL FOR ITS CITIZENS' AND WE DEMAND THAT THOSE WHO ARE STILL HELD PRISONERS SHOULD BE RELEASED. THE SOUTH AFRICAN GOVERNMENT MUST SECURE THE RELEASE OF ALL A.N.C. POLITICAL PRISONERS HELD IN FOREIGN LANDS AND IF

NECESSARY' THE ASSISTANCE OF THE (U.N.) AND THE INTERNATIONAL COMMUNITY
MUST SOLICITED TO EXECUTE THIS TASK.

WE ARE ALSO CALLING TO THE SOUTH AFRICAN GOVERNMENT TO INTERVEN
IN THE RELEASE OF MR.KATIZA CEBEKHULU.
