1. Convenor's Opening

The convenor welcomed the delegates to the meeting. He drew the delegates' attention to the report from the Management Committee regarding the reassessment of the position of the convenors. This should be discussed in the Sub-committee. He further drew the attention of the meeting to the notice sent to all members regarding the agreement dealing with political prisoners contained in the Working Group 1 Report to CODESA II, as well as the MCSC 1 decision dealing with the setting up of Task Group 1.

2. Request for postponement.

The ANC requested that the meeting be postponed in view of the crisis in the country. The ANC NEC will be meeting on Tuesday to consider the issues relating to the crisis. The ANC will thereafter communicate with the convenors, not later than Wednesday, regarding the rescheduling of the meeting.

No objections were raised to this postponement.

The South African Government requested that the ANC put the issue of the creation of a peaceful climate on the agenda of the NEC meeting.

3. Date of next meeting.

The date of the next meeting will be communicated as soon as it is determined.
