Die Rustenburg-kerkeberaad, gehou in November 1990 was verteenwoordigend van 'n baie wye spektrum van kerkleiers in Suid-Afrika. Onder andere is 'n besluit geneem dat daar 'n oproep moet plaasvind vir die hou van 'n Nasionale Dag van Verootmoediging en Gebed oor die hele land. Hierdie visie is daarna telkens versterk deur versoeke vanaf kerke en individue.

Die komitee (onder the gesamentlike voorsitterskap van drs Louw Alberts en Frank Chikane) wat verantwoordelik was vir die sameroeping van die genoemde kerkeberaad, het nou besluit dat die tyd ryp geword het vir so 'n nasionale dag van verootmoediging en gebed. The Rustenburg Church Conference held in November 1990 was representative of a very wide spectrum of church leadership in this country. Amongst others a decision was taken that a National Day of Repentance and Prayer should be called for in this country. This concept has subsequently been strengthened by many requests from individuals and churches.

The Committee (acting under the co-chairmanship of Dr Louw Alberts and Dr Frank Chikane) responsible for calling together the said convention have now decided that the time is ripe for such a National Day of Repentance and Prayer. While all the churches in South Africa will be called on to implement such a concept, it is of great importance that all political leadership in South Africa support and identify with such a venture.

It is proposed that the period Monday 1 June to Sunday 7 June be regarded as a special time to engage in acts of intercession, confession, forgiveness and reconciliation and to seek the face of God for the future of this country. Furthermore, that such a period peaks on Friday 5 June with offices, shops, business-houses, industry, etc., closing from 11:00 till 14:00, to enable all South Africans to visit the nearest place of worship of their choice for a time of meditation and intercession. The proposed period will then end on Pentecost Sunday, 7 June, in the form of regional and local services.

The Rustenburg Committee will ask and publicise that the following themes be dealt with.

- 1. Repentance toward God
- 2. Repentance toward one another as South Africans
- 3. Prayer for peace and the cessation of violence
- Prayer for successful negotiations towards a just, blessed, happy and prosperous new South Africa.

With policitical leadership's support the Committee will have more liberty to approach both public and private sectors to let make the necessary arrangements to let all employees attend the proposed meetings on the morning of 5 June across the whole country.

While this request emanates from a Christian Church Committee it would certainly be assumed and accepted that peoples of other religious persuasions will participate in a manner acceptable to them.

BRITISH GENE AL ELECTION: OBSERVERS

As you will know, a General Election is to be held soon in Britain. The Prime Minister has not yet announced the date for the election, but it will in any event take place by July this year, and you will no doubt have seen speculation in the press that it will take place rather before then.

I am writing now to say that the British Government would be happy to arrange for a group of observers from CODESA to visit Britain for a few days while the campaign for the General Election is underway, to see for themselves how we manage these things in Britain. The objective of such a visit would be to enable South Africans to observe the British practice in such areas as electoral rules, the role of the Civil Service, and access to the media: this might be helpful to them as they look forward to democratic elections in this country. In this way, my Government would hope to make a small contribution to the work of CODESA.

We would envisage the delegation of observers from South Africa as comprising four or five members, including senior representatives of some of the key players in the CODESA negotiations. The British Government would be responsible for the major costs of such a visit, including air fares to and from London and hotel accommodation in the UK.

I should be grateful, therefore, if you would consider this offer with your colleagues in the Daily Management Committee, and would let me know how you would like to take it forward. As soon as the date for the General Election is announced, we shall clearly need to make the arrangements rather quickly.

RECOMMENDATIONS TO THE DAILY MANAGEMENT COMMITTEE FROM THE STEERING COMMITTEE OF WORKING GROUP 5 REGARDING THE WORK OF WORKING GROUP 5 SUB-GROUP 1

Sub-group 1 recommends to the Steering Committee of Working Group 5 that it sends the following messages to the Daily Management Committee, to be distributed to the relevant Working Groups:

1. To Working Groups 1 - 4

Working Group 5 asks Working Group 1 - 4 to give an indication of the time schedules they envisage with regard to all their particular tasks.

2. To Working Group 1

Working Group 5 is of the opinion that real progress in CODESA's work is dependant upon the creation of the correct climate for a negotiated change to a democratic dispensation, and therefore asks Working Group 1 to address the matter of violence in South Africa as a matter of urgency.

3. To the Daily Management Committee

That the target date for holding CODESA 2 by the end of March should be adhered to if at all possible, and that it should be ensured that Working Groups 1 - 4 have made sufficient progress on which to report in order to make CODESA 2 truly meaningful.

DECLARATION OF INTENT // TERMS OF REFERENCE WG5

Note has been taken that WG5 has constituted a sub-group to look at those particular areas of the Terms of Reference of WG5 which pertain to legislation.

In this connection clarity is requested on the following areas linked to a section of the Declaration of Intent which states:

"WE AGREE ..(2) that CODESA will establish a mechanism whose task it will be, in cooperation with administrations and the South African Government, to draft the texts of all legislation required to give effect to agreements reached in CODESA"

1. Does WG5 constitute the "mechanism" referred to above ? If not then haw does this mesh with the aspect of the Terms of Reference of WG5 " to prepare in draft form the documentation which is required to give effect to such agreements" ?

2. Whether it was or is the intention to devise any other means of linking WG5 and "administrations and the South African Government" and whether "cooperation" may be fully concluded within WG5 in conjunction with the WG originating the principled decision giving rise to such legislation.

3. To what does theterm "administrations" in the above quote refer ?

4. Whether there is any conflict between the Terms of Reference of WG5 and the wording of the Declaration of Intent.

It would be greatly appreciated if you, the DMC or, if necessary the MC, could respond to these questions as rapidly as possible as we appear to be fast approaching the stage where druft legislation will have to be considered by WG5.

Dear Mr Gordhan

I refer to the invitation to discuss the work of the Commission with Working Group 1 of Codesa. As I informed you telephonically, after careful consideration I have come to the firm conclusion that I have no option but to decline the invitation. My reasons are the following.

The Commission is a judicial one. 1

- Its principal function is to hold enquiries into the phenomenon of violence. It does that in the main by means of public hearings. After completion of an enquiry a report is 2. submitted by the Commission to the State-President who decides and when to make public the findings and whether recommendations of the Commission.
- It is inappropriate for a Judge or member of a judicial commission to comment on an enquiry held by him or them save by way of an official written report. To comment in any other 3. way can lead to misunderstandings, and misperceptions. To do so, whether publicly or privately, to another body or organisation can lead to incorrect and unfortunate perceptions concerning the independence of the Commission. Furthermore, questions might well be raised at such a meeting which it would be inappropriate to answer, especially on matters concerning current or future enquiries. Indeed, a refusal to answer such questions or to discuss such matters might also lead to incorrect assumptions being made concerning the Commission.
- All of the reports already submitted to the State-President have been made public by him. It would obviously not be possible for me to discuss the evidence thus far given at 4. enquiries which are still incomplete.

It is with regret that I do decline the invitation and my doing so should in no way be seen as a slight to Codesa or a lack of appreciation of the important role being played by it.

RESPONSE TO SUB-CONTITURE ON THE DECLARATION OF INTENT AND PROPOSED AMDNEADNES

Introduction

- The IFP expresses its appreciation for the constructive spirit in which its Terms of Reference have been deliberated upon by the Sub-Committee's participants with a view to addressing the serious concerns of the IFP, as expressed by its tabled amendments to the Declaration of Intent.
- With continued goodwill, the IFP considers that there is no good reason why consensus cannot be reached in the Sub-Committee's deliberations.

IFP's First and Second Proposed Amondments (Paragraphs 1 and 5 a and d of the Declaration of Intent)

- 3. The Sub-Committee's approach, to acknowledge the principle that there are sincerely held differing interpretive views of the intentions expressed by the language of the Declaration, is a sound starting point.
- 4. Likewise, the IFP sees the difficulties inherent in reventing to the signatories of the Doclaration and asking them to approve formal amendments thereto. The IFP approves therefore in principle the proposed method of going forward, namely, providing a means whereby all signatories will declare that irrespective of differing interpretations which

may exist between them in regard to the Declaration, there will be total freedom by any participant to advocate its views on forms of government of a democratic nature during proceedings of CODESA and its Working Groups.

- 5. It can only be described as unfortunate and regrettable, in the JFP's view, that the wording of the Declaration had the effect of inmediately excluding altogether from COPPSA at least one important political player. The IFP would like to think that in the current process of re-examining the Declaration from its stand point, which is that CODEDA is not sufficiently inclusive as presently constituted while political players such as Azapo, PAC and the CP are not participants, the effort should be made to arrive at a formulation to encourage such wider participation. The IFP helieves that CODEDA is only laying up future problems for itself and the country while it reflects its current periodsly flayed inclusivity.
- 6. In the IFP's view the first proposal with regard to the IFP's proposed amendments, reflected in 2.1 of the 'limites of the Sub-Committee held on 17 February 1992 does not much the IFP's position sufficiently, for the following reasons -
- 6.1 the formal statement proposed to be issued by the Management Committee and by CODENA must be precated and agreed to now as purt of the current deliberations and not merely left to the Management Committee later to decide upon;
- 6.2 signatories cannot declare the Declaration of Intent "is neutral" on the issue of a unitary versus a federal state when that issue is precisely a source of serious contention;

- 6.3 the formal statement referred to in 6.1 should take the form of an Addendum to the Declaration of Intent to be adopted by signatories to the Declaration of Intent at CODESA II as a mark of their solern, clear and unambiguous commitment to its terms, thus specifically incorporating it into the main document by reference as an annexure thereto;
- 6.4 it should be more general in its conceptualisation of constitutional models which can be freely debated in CODECA, the only rider being that they should be consistent with democracy. It should not simply or necessarily be a matter of negotiation between a straight unitary versus a federal constitutional model. This would completely accord with and add force to the paragraph of the Declaration of Intent numbered i under "We agree" reading "that the present and future participants shall be entitled to put forward freely to the Convention any proposal consistent with democracy".

The IFP therefore tables before the Sub-Committee the following proposed Addendum for consideration
