REPORT ON:

The creation of an A.N.C legal dept.

Sat 5.12.81 - The first session was convened with the participants comrades Albie Sacks, Sibongile Mkula and Ted Pekane. The meeting started at 09.00 hrs.

3. Have our own research centre - e.g. A.N.C. library equipt with legal documents.

4. Have files on the A.N.C. and Bantustans.

5. Have a summer school starting from next August.

7. Cde Albie to write on allocation.

8. Cde Albie to make recomendations that we are full time in this dept.

A.N.C. WORKSHOP INTERNATIONAL LAW (PROPOSAL)

The objective is to strengthen work in the International field, to create nucleus of A.N.C. legal workers capable of responding to the politico-legal needs of the organisation, and to develop some preliminary ideas on the legal framework of future South Africa.

PARTICIPANTS

Cadres from the International Department. Representatives. Cadre from Umkhonto We Sizwe. A.N.C. members who are lawyers, law teachers or law students.

TIME: About 7 - 10 days in the period July - August 1982.

Place: Anywhere where the participants could in an atmosphere without distractions or interference, preferable in reasonable comfort with food and accommodation provided. Cde Tony Mongalo has indicated that if the idea were approved of the G.D.R. could probably offer facilities. Alternatively, there are contacts in Italy who could probably arrange facilities, alternatively, in Austria. An Alternative possibility would be somewhere in Africa, possibly with support of the O.A.U. e.g. in Ethiopia.

2. International Organisations (Political) - UN, O.A.U., Non-Aligned Movement. Their history, structures and functioning.

3. International Organsiations (Economic)

- 1. The legal Status of the A.N.C as the National Liberation Organisation of South
- Africa. ANC trave and marriage documents. Problems of discipline and punishment.
- 2. The Racist Contitutions of South Africa from 1910 to Today.
- 3. The Bantustans in Internal Law and International Law.
- 4. The Legitimacy of Armed Struggle in South Africa; International Humanitarian Law and the Status of Captured Combatants.
- 5. The Freedom Charter as the basis of a National Convention and Contitution for a Free South Africa.
- 6. International support for the Liberation struggle.

The persons responsible for preparation discussion documents and orienting the discussion will be Abie Sachs and Kader Asmal, but all comrades with experience in particular fields will be expected to lead discussions in these fields (e.g. on the functioning of international organisations; diplomatic practice etc.).

The objective will to share ideas, and, within the framework of ANC policy goals and methods of work, to arrive at a consensus on all the major theme. The rates of the Workshop could then serve as the basis for an ANC booklet.

Finally, it would be valuable to have a senior representative of the N.E.C. to launch the workshop and preside over the opening session so as ito stress that this is not just a side-line activity for a few specialists, but the development of an important instrument to back up the people's struggle inside and outside the country.
