1. Chairpersons opening remarks

The members were welcomed. Those members who did not go to Britain were thanked by the Chairperson for managing DMC affairs.

2. Apologies

The following apology was noted:

It was further noted that ZJ de Beer, FT Mdlalose and SS van der Merwe would leave the meeting early.

3. Adoption of Agenda

The agenda was adopted with no amendments.

4. Ratification of minutes

4.1 The minutes of the meeting of 30 March 1992 were ratified with the following amendment:

- * Item 3 "T Hendrikse" should read "P Hendrickse".
- 4.2 The minutes of the meeting of 6 April 1992 were ratified with the following amendments:
 - * Item 2 Under apologies the following was inserted: "The above members were absent from the meeting as they formed part of the delegation to the United Kingdom to observe the British Elections."
 - Item 5.1.2 would now read "The local Diplomatic corps would also be invited, as was the case for Codesa 1."
 - * Item 5.2.4 would now read "The wording of the invitations should indicate that Working Groups will report back on their work to Codesa 2 including the substantive agreements arrived at."
 - * Item 5.3.1 The word "by" is replaced by "be."

5. Matters arising from the DMC minutes of 6 April 1992

- 5.1 Item 5.7 refers It was reported back that ZJ de Beer had contacted the joint Chairpersons of Codesa 1 and apologised for the lack of contact from the Secretariat and the Administration. ZJ de Beer was well received.
- 5.2 Item 5.6 refers It was noted that R Meyer and T Eloff had met with Professor Heyns. The meeting with Bishop Magoba has not yet taken place. It was agreed to leave this issue open until a report is available.

6. Matters arising from the MC minutes of 30 March 1992

6.1 Media:

This matter has been attended to by the DMC meeting of 6 April 1992.

6.2 Marketing of Codesa:

The Secretariat is still working on preparing recommendations in this regard.

6.3 Follow up meeting of the WGSC's and the DMC to discuss Codesa 2 and any other related issues:

The meeting is scheduled for Tuesday 28 April 1992 at 15h00 and will be attended by two members of each WGSC, the GAC Steering Committee and the DMC.

6.4 Meeting between members of the DMC and the WGSC 5 on the issue of drafting:

This meeting will take place on Tuesday 28 April 1992 at 13h00. Z Titus is to liaise with the Secretariat in this regard. The DMC members to attend this meeting are PJ Gordhan, P Hendrickse, R Meyer and Z Titus.

6.5 Rustenburg Church Proposal:

The letter sent to the Church Leadership Committee on behalf of the MC was noted. It was further noted that this issue has been receiving publicity from the Church Leadership Committee.

7. Matters arising from the GAC

- 7.1 The GAC have requested that point 1.2 of their Terms of Reference be amended to include one adviser per delegate. It was agreed that the DMC would recommend the acceptance of this amendment to the MC meeting of 27 April 1992.
- 7.2 The right of substitutions in meetings of the GAC was agreed to.
- 7.3 Request that amendments be made to paragraphs 2 and 4 of the Terms of Reference:

It was agreed that the requests are procedural and do not require the amendment of the Terms of Reference. A distinction needs to be made by the GAC, between matters of procedure and principle. It was noted that the DMC does not have any objections in principle to this request but it was agreed to communicate with the GAC in this regard when their written report stating all their recommendations/proposals is received.

7.4 Request for access to submissions outstanding from documentation already received by the GAC:

The Administration is to assist in this regard.

7.5 Request for office space:

It was agreed to supply an office for the use of the GAC. The Secretariat is to assist in this regard.

7.6 Information on the role of rapporteurs:

The GAC will contact the Secretariat in this regard and the necessary extracts will be made available.

7.7 Request for a permanent secretary and minute taker for the GAC:

The Administration is to assist in this regard and a permanent secretary and minute taker will probably be allocated to the GAC by Monday 27 April 1992.

7.8 Representation of women in Codesa 2:

It was agreed this would be achieved through the delegations to Codesa 2 from the different participating organisations/parties/administrations.

7.9 Priorities for Codesa 2:

This was referred to the joint meeting of all WGSC's and the DMC scheduled for Tuesday 28 April 1992 at 15h00 which would include two representatives of the GAC.

7.10 The question of language in Codesa:

It was suggested that a circular could be sent out in this regard but this would be further dealt with when the written report containing all recommendations/proposals is received from the GAC.

8. Report from the delegation to the United Kingdom

- 8.1 A brief verbal report was given which is to be followed up with a full written report to the DMC and the MC.
- 8.2 It was agreed, by the delegation, that the visit had been a success and a useful binding experience.
- 8.3 It was noted that all documentation from the visit would be distributed to each organisation in Codesa.
- 8.4 It was agreed that a letter of thanks should be sent to the British Government also noting that the delegation is available to give the British Ambassador direct feedback should such feedback be required.

9. Codesa 2

9.1 Security sub-committee:

It was agreed that the heads of security, Mr Venter and Mr Reddy, should be invited to address the next DMC meeting on the internal security arrangements at Codesa.

- 9.2 Item 5.2.2 of the DMC minutes of 6 April refers. This would only possibly come into effect if the number of delegations within the conference should increase for Codesa 2.
- 9.3 It was noted that the Secretariat and the Administration are still to submit a report to the DMC in respect of logistics for Codesa 2.
- 9.4 The report on "Applications to join Codesa" (Addendum A) was noted and referred to the next meeting of the DMC with a view to making recommendations to the MC meeting of 27 April 1992.

10. Sub-committee on the Participation of the Zulu King and other Traditional Leaders

The following was noted:

- 10.1 The Chairperson of the DMC reported that members of the press had approached him during the course of the day to confirm a statement made by the Chairperson of the sub-committee on the participation of the Zulu King and other Traditional Leaders in Codesa. This statement is alleged to have confirmed that tentative agreements had been reached in the sub-committee on the form of participation of the Zulu King and other Traditional Leaders in Codesa.
- 10.2 The Chairperson reported that he then had a discussion with Mr Mohapi to make him aware of the sensitive nature of the work of this sub-committee and to inform him, once he confirmed that he had made such a statement, to exercise greater discretion.

- 10.3 The DMC expressed its support for the actions of the Chairperson. It was agreed that the chairperson and other members of the DMC should speak to the chairperson of the sub-committee in this regard. It was further agreed, that a press statement correcting the report given by the chairperson of the sub-committee should be issued by the DMC.
- 10.4 The two members of the DMC who are members of the sub-committee on the Participation of the Zulu King and other Traditional Leaders in Codesa reported that the work of the sub-committee is still continuing and that further submissions are still to be heard. The sub-committee is meeting on Monday 27 April 1992 at 07h30 to continue its work.

11. Report to the MC meeting of 27 April 1992

It was agreed that the Secretariat and the chairperson of the DMC would attend to this.

12. Press Briefing

It was noted that a press briefing is scheduled for 22 April 1992. It was agreed that the following issues should form part of the briefing:

- * The statement on the Participation of the Zulu King and other Traditional Leaders at Codesa
- * Report on the visit to observe the British Elections
- Rustenburg Church Leadership Proposal
- * Any reports from the Working Groups

13. Other business

- 13.1 A request from the South African Communication Services, to make a recording of a working group in session but with no sound recording, was noted. It was agreed that the Secretariat should further explore this matter.
- 13.2 It was noted that the chairperson of the DMC would participate in a talk show on SABC radio on 30 April 1992 in respect of Codesa.

14. Next Meeting

The next meeting of the DMC will be held on Monday 27 April 1992 at 13h00.

The meeting was closed at 19h30.

REPORT RE APPLICATIONS TO JOIN CODESA

1. Introduction

- 1.1 In the process up to and including CODESA 1, it was agreed that political parties/organisations, administrations and the South African Government shall be participants.
- 1.2 So far the Management Committee (MC) has attended to the various applications in the following way:
 - 1.2.1 The question of traditional leaders and organisations of traditional leaders is receiving attention through the special sub-committee set up by the MC. In this regard it should be noted that the Terms of Reference of this Sub-Committee include the following: listed therein under Clause 2.2.4:

"The possible effect the Sub-Committee's recommendations will or may have on the present composition and constitution of CODESA should be looked at and reported upon."

- 1.2.1.1. Attached is a list of 11 applications which have been classified under the category "Traditional leaders and organisations". (Section I)
- 1.2.2 Applications from organisations which prima facie do not qualify as political organisations have been treated under the category "interest groups". Accordingly they have been refused participant status but have been accorded opportunities to make submissions to Working Groups.
 - 1.2.2.1. Attached is a list of 14 organisations which have been treated as falling under the category "Interest Groups". (Section III) This list should be taken together with the 4 organisations which have applied for observer status. These appear under Section V, headed "Observer Status" applications. We suggest that they be treated as interest groups.
- 1.3 What follows hereunder is therefore focused on guidelines in terms of which applications which prima facie come from political parties/organisations seeking to be admitted as participants in CODESA.
 - 1.3.1. Attached is a list of 17 organisations which could be seen as possible political parties/organisations (Section II).

2. Steps taken to facilitate processing:

2.1. We commissioned a report based on a fairly exhaustive search of reportage in South African newspapers including weeklies, in order to determine what sort of press coverage such applicants enjoyed during the period 1/1/1991 to 31\1\1992. Of the 17 applicants, this report showed that only two of the applicants had received some coverage, namely the Federal Independent Democratic Alliance (FIDA) and the Pan-Africanist Congress in South African.

A summary of the coverage that these two organisations received in the press is attached.

- 2.1.1. Specifically in the case of FIDA, there were 6 reports covering three aspects. (a) Two reports stating that FIDA wants to join CODESA; b) two reports about FIDA's funding in particular from government sources; and c) two reports with regard to ANC "dissidents" joining FIDA.
- 2.1.2. With regard to its membership at different times and on different occasions has claimed membership a membership of 20 000; 400 paid-up members; and close on half a million.
- 2.1.3. In the case of the PAC of SA, three reports appear in the press all during the period of December. Dealing with the desire of this organisations to join CODESA and claiming that it represents a section of the PAC of Azania.
- 2.2. In commissioning this report, it was hoped that press coverage would give us some indication as to whether any of the candidates exist as a viable political entity and enable us to have some understanding of the applicants' support/membership. It is clear from the above that the analysis of the press coverage does not provide us with any evidence in favour of a conclusion which would suggest that a particular applicant enjoys some measure of proven support. In the case of FIDA nothing emerges in the direction of a political programme of activity.
- 2.3 In addition to the above steps the MC prepared a questionnaire to be sent to each of the applicants (see Annexure B). The questionnaire was framed in a manner that would help us to determine the activities, membership and physical existence of the applicant as a political entity.
- Suggestions/recommendations with regard to the 17 applications of possible political parties/organisations listed in the annexure:
 - 3.1. From these applicants, 8 have not replied to the questionnaire which was sent out early in February. We suggest that the failure to reply taken together with the fact that the press analysis shows that none of these 8 received any coverage whatsoever should be taken to imply that these applicants are not following up their applications with any seriousness. Accordingly we would suggest that their applications should be turned down. Particular attention in this context should be drawn to the application of the Pan Africanist Congress of South Africa the press coverage it received is summarised in Paragraph 2.1.3. above. However it has not replied to the questionnaire and we therefore suggest that it should fall into the category of rejected applications.
 - 3.2. With regard to the remaining 9 applications is a summary of their responses to the questionnaire is attached. With these responses and bearing in mind the analysis of the press coverage for the year 1991 we suggest the following:

3.2.1. Afrikaner Party:

- 3.2.1.1. This party received no press coverage during 1991.
- 3.2.1.2. A summary of the questionnaire shows that it has only published 2 publications: (i) Introducing the Afrikaner Party and (ii) Codesa's Secret Forebears. There is no indication of any political activity. It has no presence at parliamentary, local government or civic levels. It is unable to provide any membership figures.
- 3.2.1.3. We suggest its application be rejected.
- 3.2.2. Federal Independent Democratic Alliance (FIDA)

- 3.2.2.1. A summary of the press coverage it received appears in paragraphs 2.1.1./2 above.
- 3.2.2.2. It has provided no reply to the questionnaire seeking its rules of membership. Its response with regard to activities would seem to be highly exaggerated. eg. it claims that rallies held in 1991 drew crowds between 800 and 3000 people In this regard it received no press coverage for any of these rallies. Aside from this, it gave no other information regarding its membership.
- 3.2.2.3. We suggest its application be rejected and that it should be invited to make submissions to Working Groups on matters relevant to any particular Working Group's Terms of Reference. Ie. It should be treated as an Interest Group.

3.2.3. Freedom Party of SA

- 3.2.3.1. It received no press coverage in 1991
- 3.2.3.2. It claims a membership of 10 000 in the Western Cape. It has not provided any reply indicating activities with regard to meetings and publications. It has one member in the House of Representatives. In spite of its claims as to membership it goes on to state that it obtained 118 votes in the 1984 General Election, and that in the September 1989 General Election its sole Member of the House of Representatives received 900 votes.
- 3.2.3.3. We suggest its application be rejected.

3.2.4. Insika National Party

- 3.2.4.1. It received no press coverage in 1991.
- 3.2.4.2. It did not complete the questionnaire. It disclosed only 1 office bearer, namely the president; it claims it has members in the Kangwane Legislative Assembly but does not indicate how many. It has not disclosed rules of membership, or activities except to say that it holds conferences annually.
- 3.2.4.3. We suggest its application be rejected.

3.2.5. Merit Peoples Party

- 3.2.5.1. It received no press coverage in 1991.
- 3.2.5.2. Its activities are confined to Lenasia. It has two members in the House of Delegates and 1 member in the Local Management Committee of Lenasia. With regard to the 2 members in the House od Delegates, we draw attention to its reply:

"In General Election 1989 fielded 3 candidates all of whom were returned to Parliament. An Additional Member of Parliament was nominated. 2 members have since joined Solidarity There is an understanding that the independent members of the House of Delegates will be included in Merit People's Party's delegation to Codesa."

3.2.5.3. We suggest its application be rejected.

3.2.6. National Seoporsengwe Party

- 3.2.6.1. It received no press coverage in 1991.
- 3.2.6.2. It operates in Bophutatswana. It was in the Bophutatswana Parliament from 1972 to 1982. It claims a membership of 19 320 in 1990.
- 3.2.6.3. In reply to our questionnaire, we draw attention to Paragraph 6.1. of the reply:

 "Parliament: (Bop) 1972 1982 In spite of harassment and intimidation. 1982/1987, the dark years of repression. Sixty five arrests and detentions (including the leader of the Party) in one region alone and within 3 days August 27-30/1986, discharged and sued government Out of Court settlement. Abuse of electoral system leads to litigations, favouring Party in 3 instances. Internal Security Law successfully challenged in "Supreme Court but lost on appeal of government in court of appeal of enclave"
- 3.2.6.4. We suggest that this application be processed together with the application of the Peoples Progressive Party by the Management Committee.

3.2.7. Peoples Party of South Africa

- 3.2.7.1. It received no press coverage in 1991.
- 3.2.7.2. From its reply to the questionnaire it claims 4 members in the House of Delegates. Its activities appear to be confined to Benoni/Actonville and Lenasia.
- 3.2.7.3. We suggest its application be rejected.

3.2.8 Peoples Progressive Party of South Africa

- 3.2.8.1. It received no press coverage in 1991.
- 3.2.8.2. Its reply claims a membership of 49 689 in 1987. It held a national congress in October 1991 attended by 365 delegates representing 193 branches and 157 observers. Among its public activities it states that it held a public rally at Phokeng on 23 November 1991 which was attended by 12 000 people.
- 3.2.8.3. In Paragraph 3.2.6.4. above ,when dealing with the application of the National Seoporsengwe Party we suggested that the applications of the NSP and the PPP be considered by the MC at the same time.

3.2.9. Reform Party of South Africa

- 3.2.9.1. It received no press coverage in 1991.
- 3.2.9.2. It states that it has one member in the House of Delegates and 6 members in various local affairs committees.

- 3.2.9.3. This party appears to have effectively ceased to exist in the 1980s. Its current "revival" is related to the coming into being of Codesa. Since its application its activities re-Codesa have resulted in press coverage in Natal in 1992. This press coverage relates to admissions by the Reform Party, that it is recruiting members in the legal fraternity in the Indian community with the promise that such members will be made delegates in the Codesa Working Groups.
- 3.2.9.4. We suggest its application be rejected.
