Dear Albie,

I am writing to update you on the progress of our forthcoming production of Soft Vengeance, adapted from your book by our commissioned writer April De Angelis. I am aware that Joy has brought you upto date slightly, but thought I would fill in the details!

A copy of the Third Draft of the script is on its way to you as you read this. It should arrive within the next three days.

So far the production is progressing really well, with the opening planned in London for 14th September. As Joy I think has mentioned, we are planning a Gala performance of the production as a benefit on 17th September and would very much like you to attend if this is at all possible. We are currently working on the guest list but they will include all the national press, potential corporate funders and others of importance and influence! The aim of the evening is both to raise funds but also to assist raise our profile!! I understand that you may have to be in Harvard. I wonder whether it is possible for us to contact them and ask them either to rearrange for a day later, or whether you would be willing to take a late flight on 17th. We would ensure that a taxi was waiting at the theatre to take you to the airport!!

I wonder if you could either let me have your contact at Harvard to discuss the matter with, and confirm whether you would be willing to attend this performance.

Secondly, we are visiting several theatres and arts centres which are based on University campuses or are associated with local Universities. Several have enquired whether you are planning a lecture tour in the Autumn or the near future. This is obviously a separate matter to the production, and for which separate fees are available. Should you be available, I would be willing to assist in the planning of these. Do let me know and I can proceed.

Finally, we have recently been invited to perform at The Market Theatre in Johannesburg. The Market are very willing to offer us all our 'in country expenses'. I am currently trying to raise funding from the international costs (e.g. flights etc) Current estimates are in the region of £6,000 sterling. Are you aware of any sources that might be interested within South Africa? Sorry to ask you these questions, but I am getting a bit stuck thinking of sources at this end as The British Council do not fund any work visiting South Africa. They do not have a policy! Should you wish to discuss the matter further, and obviously we would have to have your agreement, do please contact Michael Maxwell, the General Manager of the Market.

If you need any further information, please do not hesitate to contact me.

We look forward to meeting you in September.
