
We are hereby applying for registration as one of the parties to take part in the activities of the All Party Conference.



RE : APPLICATION TO PARTICIPATE IN CODESA.

Kindly accept our apologies for the delay in responding to your letter in which you were responding to our application to participate in CODESA.

Our executive resolved that we must forward you with the following information:

1. We are a bona fide political party.
2. This party was established in 1988, long before CODESA came into being.
3. We are a registered political party in KaNgwane - Registration Certificate Number : 8/9/2 - 2/88.
4. We hold conferences annually.
5. Our party is represented in KaNgwane legislative assembly.
6. We have paid our annual fee for the party, of which you will find a copy attached.
7. Our mission statement is as follows :

To foster the development of the Swazi people as members of secured nations in a multiparty democracy.

Therefore as it is abundantly clear from our mission statement, we are entrusted with a great task of securing the Swazi people in South Africa. There are more than one million Swazi's in the Republic of South Africa.

Lastly, it is with deep regret and dismay that we have come to hear of information which flowed out from CODESA. A Mr Dube A.B. of Inyandza National movement told me that our chances of being accepted in CODESA is zero. This is due to the fact that it is not clear as to whether we are for a unitary and one nation in South Africa or not. This was published by the very same Dube in his "Kusile Ngwane" publication which he distributed in the legislative assembly during the special secession on the 14 February 1992.

We do not doubt that Inyandza is canvassing behind the scene our exclusion from CODESA because:

1. We were taken to Court simply because we registered as a party (One Party Region).
2. They tried in vain to move a motion purporting to expel members of Insika Party from the legislative assembly. This resulted in members crossing the floor.

We are sure that Inyandza would not hesitate to use any opportunity at its disposal to pin down Insika Party. It is up to CODESA as to whether they wish to appease Inyandza or not.

We are prepared to come for a personal interview if we are called to do so.

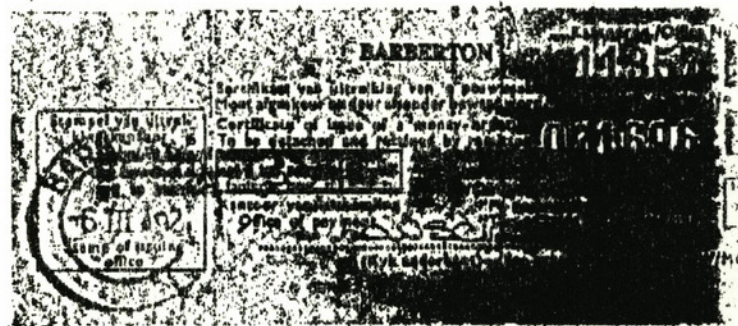

PREFACE

The Insika National Party represents, largely, The SWAZIS in the R.S.A. as a Nation. However, we are not prepared to forfeit our identity as SWAZIS with all our traditions and customs. Our goal is democracy and freedom for all South Africans.

We SWAZIS in S.A. have strong contacts with the SWAZILAND monarchy under King MSWATI III. We will not expect to be denied our rights, to observe ALL Traditions, Customs and Ceremonies which our mainland brother and sisters strongly observe. The Main ceremony being the Incwala which we will fully respect and take part in.

We strongly and hopefully believe that the NEW SOUTH AFRICA will not bring domination by the stronger parties on their counterparts who would not enjoy the same status enjoyed by the latter. The same applies to ethnic groups. Strong ethnic groups will be expected to respect and observe ALL the rights of existence for the minor ones and thus the peace that we all cry for today will be enjoyed in harmony for decades to come.

The good of ALL SOUTH AFRICANS as a Nation should stand above party politics - that is the state as an institution of mankind should enjoy first priority in all matters. Be they political, economical or social.

BASIC PROPOSALS ON A NON RACIAL DEMOCRATIC SOUTH AFRICA

THE EXECUTIVE

Executive Powers should be divided between the State President and the Prime Minister who will lead the cabinet. The President will exercise some powers laid down within his jurisdiction and others will exercise with the advice and consent with the Prime Minister. This means that the two will have to work closely and hand in hand in the running of the country. Their powers will be clearly defined to avoid one man having too much power which may prove to be dangerous as the case has been somewhere else.

THE LEGISLATURE

- (i) The house of assembly will be elected into parliament by all parties taking part in the elections. It is hoped that all the parties will be represented in the house and the same house should elect the Prime Minister who will in turn appoint his own cabinet.
- (ii) The Senate House shall comprise all states representing the cross section of the population throughout the Republic.
- (iii) The two houses will be expected to make laws that will be suitable for all South African Democratically. Minor parties should not be found to be suffering because of their minor status. The Senate House should be expected to be redeemer of the minority represented parties in the lower house or House of Assembly. We believe that in this structure all South Africans will enjoy our equal representation in the law making institutions of the Republic.

STATE GOVERNMENT

We would like to see a new South Africa comprising all the homelands, regions taking the forms of States with their own governors reporting directly to the Central Government in the office of the State President.

Prisons Department will be expected to be of service to the entire nation.

The army shall as well be service to the National Security and State President should be Commander-In-Chief. In issues of the army, the President will work with the Defence Council which will be chaired by the Army Commander. The Minister of Defence should be a member of the Defence Council. Local states will be expected to be served by relevant battalions.

POLICE

The Police shall be under the Prime Minister and they will work to protect all the laws abiding citizens of the Republic. They will be expected to work unlimited as far as investigating the truth is concerned. They will be the vital source of attracting investors into the Republic, as common business sense has it that no investors would come into a lawless-country.

TRIBAL AUTHORITY

We favour a situation which not deny our Chief, their status over their subjects. Chiefs will continue to be the fathers of their subjects as the case is with our Swazi Traditions and customs. Chiefs will enjoy tribal authority as clearly defined by the Swazi way of life. The same Chiefs will also be responsible for conscientizing the people about our connections to the mainland monarchy in Swaziland.

No one will be expected to be punished or tortured for respecting his tribal authority.

HOUSE OF CHIEFS

Chief should be assimilated into the new South Africa. A House of Chiefs comprising all traditional leaders should be established in the Houses.

In that way, the creation of State Governments will clearly and comfortably leave all people enjoying their customs, traditions and basic social rights as people. We propose for a clear sketch of state boundaries.

On the same token, we would like to see a situation where the Cabinet will also comprise all the parties as represented in the legislature.

JUDICIARY

The Chief Justice should be expected to handle justice equally and protect all the law abiding citizens of the country. A judicial service commission shall be responsible for supervising all the courts. The Chief Justice will be the Head of Judicial Service omission. The High Court or Supreme Court will handle all big cases in the gravity of murder, High Treason or Sedition.

CIVIL SERVICE BOARD

The C.S.B. shall be the organ with which the state shall supervise and recruit its workers. General orders issued by the Premiers Office will be guidelines of the civil servants as Government employees. The same C.S.B. will be responsible for transfers of the public servants and also should motivate the civil servants to serve the State uprightly. It shall have the powers to discipline corrupt civil servants. However, that would be done in consent of the PMS office. Civil servants shall not be expected to take part in politics once in the office. Theirs is to serve the Republic and Nation not party or political inclinations.

THE FORCES

We advocate for an objective professional standard force that will serve all the interests of the nation. The Police Commissioner, Prisons Commissioner and Army Commander shall be appointed on merit by the state president.

HUMAN RIGHTS

We will strongly advocate for the recognition of ALL RIGHTS which are enjoyed by all people in the world. All rights under the UN Declarations will be observed in full.

These include the rights to our land, the right to live, education, religious, cultural, traditional, linguistic, freedom of speech and expression and association plus movement.
