

GUIDELINES FOR NATIONAL LIST TO NATIONAL ASSEMBLY

- 1. Each region will receive the names of their first 400 positions. These are divided into the top 200 which are ordered alphabetically, with no indication of position as these lists will be compiled into the ballot form for the National List Conference. Positions 201 400 will be ordered in the same manner. The second list allows for withdrawals, duplications and an insufficient number of women on the first 200 positions.
- 2. The list committee will confirm acceptance of all names on the regional top 200 positions.
- 3. The list committee will correct all errors on the present list.
- 4. The list committee will implement the NEC decision on affirmative action to ensure that one third of the ballot paper consists of women.
- 5. The above steps will result in the final list for the National Assembly from each region, which will equal 200.
- 6. The ballot paper for the National Nominations Conference will be a merger of the names of the top 200 candidates from each region. This will result in a ballot paper of approximately 500 (after duplications between the regional lists are consolidated into one).
 - 7. The National Nominations conference will be held on the 15 January 1994. This conference will comprise of 500 delegates. Elections will be held for the National List for the National Assembly only.
 - 8. After the National Conference the list committee will have to apply the NEC decision on affirmative action to ensure that at least one third of the final list are women. The list committee will then present their proposal to the NEC on 16 January 1994.
 - 9. The NEC on the 16 January will then finalise all the lists, after looking at objections received. The conference will be facilitated by IMMSA.


