APPLICATION FOR ALLOWING INGWENYAMA (KING) D M MABHOKO'S DELEGATION
TO CODESA.

1. INTRODUCTION

I hereby apply to Codesa that I be allowed to sent my full delegation (12) plus advisers to Codesa.

I am the Ingwenyama (King) in KwaNdebele. I may state that I played a significant role in the political and constitutional development of this country as it will be seen from facts set out below.

2. BACKGROUND

The kingdom (ubungwenyama) of my nation can be traced back as far as the 15th century based in the Transvaal. The first King (Ingwenyama) of this nation known to history is Ingwenyama (King) Mafana who ruled at Emhlangeni and was followed by Ingwenyama Mhlanga who also ruled at Emhlangeni in the Transvaal. The latter's successor was King Musi who ruled at KwaMnyamana (Emarula) in the Transvaal. All these Kings ruled during the years 1550-1580. The next King Ndzundza who ruled at KwaSimkulu in the years 1620-1660. He was followed by King Mrhetjha, Magobholi, and Bongwe who also ruled at KwaSimkulu. King Sindeni, Mahlangu, Phaswana, Maridili, Kawule, Mgwezani, Dzela, Mrhabuli, Magodongo, Siboko and Somdeyi ruled at KwaMaza in the years 1660-1840. King Mabhoko, Mkhaphuli, Rhobongo and Nyabela ruled at KwaNomtjharhelo near Roossenekal.

Of the above Kings, King Magodongo was killed in a war between my nation and the troop of Mzilikazi from Natal while going through the Transvaal to Rhodesia (Zimbabwe). The successor of King Magodongo was King Siboko and Somdeyi ruled at KwaMaza too, in the years 1660-1840 in the Transvaal.

It is also worth noting that King Nyabela ruled KwaNowtjharhelo near Roossenekal in the Transvaal; It was during his time that we realized leadership of my nation resisting the undermining of powers and authority of Traditional leaders. It was also during his leadership that we noted the head of my nation resisting apartheid in South Africa.

It was during his rule when the Zuid-Afrikaanse-Republiek claimed a right of authority to punish Kgoši Mampuru of the Bapedi tribe. This right claimed by Zuid-Afrikaanse-Republiek was totally rejected by King Nyabela of my nation because he knew no leadership of Zuid-Afrikaanse-Republiek which was democratically elected by all the people in South Africa. He found it to be discriminatory and apartheid in a best sense to have people whom you have not elected to claim authority of government over you. It was as a result of this resistance of King Nyabela that a war ensued between the Zuid-Afrikaanse-Republiek and my nation in 1882-1883 as a result of which my people were scattered all over the country.

My grand father King Fene ruled after King Nyabela during the years 1910 to 1922 at Welgelegen near Delams in the Transvaal. My father King Mayisha ruled during the years 1922-1961 at Weltevrede, at my present Royal Residence.

It was during King Mayisha's rule that a strong resistance against apartheid by the leadership of my nation was observed. King Mayisha refused the Bantu Authorities's system under the 1953 Bantu Authorities Act.

King Mayisha felt the Bantu Authorities Act was based on apartheid laws which amounted to fragmentation. He rejected this and persisted in such rejection until he died in 1961. I, Ingwenyama D M Mabhoko II took over the reigns of leadership from King Mayisha my father in 1961 and since then up to now I am still ruling my nation from my Royal Residence at Weltevrede.

2.1 KING D M MABHOKO

As I already said I assumed leadership of my nation in 1961 and I was immediately confronted with the question of Bantu Authority System which my father rejected. I also rejected this system. During the years 1961-1968 a heavy pressure was placed on my nation by denying the employment, any improvement apparently as a kind of punishment on me and my nation because of my rejection of Bantu Authorities : System. In 1968 I had to accept the Bantu Authority System so as to let my nation to survive.

In 1986 I strongly opposed and rejected the planned Independence against the will of the then KwaNdebele government. It is my contention that KwaNdebele never gained independence under the apartheid system because of my able leadership in political affairs. It is further my contention that KwaNdebele politicians of 1986 would have led KwaNdebele to independence had I not intervene independence.

3. CONCLUSION

It is against the above mentioned background and the special role I played in politics that I feel I am entitled to sent my delegation to Codesa over and above the Intando Yesizwe Party which I support so dearly.

May my application be considered favourably so that I can be able to sent my full delegation of (12) members and their advisers.

Reference is made to our letter dated and faxed 17 December 1991. We have awaited your response thereto to date. At its meeting held Saturday 18 January 1992 the National Council (NC) of the Party (NSP) instructed that an urgent letter be directed to the Steering Committee (Management Committee) of Codesa urging consideration of and reply to the application of the Party as above and in its right as the only opposition Party with a viable constituency and registered in the territory and in this particular; attention is drawn to (in our view) the anomaly that representation at Codesa (which we accept) should have been accorded to the government of Bophuthatswana to the exclusion of views and organisations in opposition to it and to the regime which spawned Bop on policies internally and internationally condemned as a heresy and a crime against humanity. The NSP is aware of representation accorded several homeland, political parties other than governments and wonder why an exception will seem to have been made with regard to Bophuthatswana and its government with dwindling support and contrary to what it wants the world to believe. A mini-referendum for Bop and monitored by Codesa should remove any doubt/s if any, as to who enjoys majority support, the opposition or the government as it claims on the basis of results of general elections conducted and manipulated by government.

On our argument, Codesa could hardly claim to be representative as far as Bophuthatswana is concerned. It is not too late to correct this error.

1. Documentation

The timeous circulation of documentation for all CODESA meetings was again emphasised.

2. Working Groups

2.1 'Memo from the Secretariat to the DMC Concerning Certain Aspects Aimed at Facilitating the Functioning of the Working Groups'

2.1.1 It was agreed that an amended version of this document and its addendum ('Notes on Opening Remarks of Convenors of the First Session of Working Groups') should be presented to each of the five Working Groups, and that the suggestions contained therein should be seen as flexible and open-ended.

2.1.2 It was agreed that, for the sake of clarity, the management committees of the Working Groups will be referred to as Working Group Steering Committees (WGSCs).

2.2 Convenors of the first session of the Working Groups

2.2.1 It was decided that the first session of the Working Groups should be convened as follows:

2.2.2 It was agreed that Dr Z de Beer, Mr M Maharaj and Mr S van der Merwe should monitor the proceedings of each of the Working Groups with a view to identifying possible trouble-spots.

2.2.3 The option of the DMC meeting over lunch to attend to any such trouble-spots was noted.

2.3 **Draft agenda**

An amended version of this document was adopted.

2.4 **Future meetings**

It was agreed that Working Group convenors should recommend that the Working Groups next meet on Thursday 6 February. Thereafter, was recommended that meetings should take place on Mondays, with the proviso that business may be carried over to Tuesdays when necessary.

2.5 **Inclusion of the Transkei proposal in Working Group 3's Terms of Reference**

It was agreed that the proposal as outlined under Item 3.2 of the 'Secretarial Report to the Management Committee Meeting of 13 January 1992' should be raised by the Transkei delegation to Working Group 3.

2.6 **Public information/media**

2.6.1 Mr P Gordhan requested that the matter of information to the public on Working Group proceedings should be raised at the next DMC and MC meetings.

2.6.2 It was agreed that the DMC should issue a statement to the media on the day's proceedings.

Action

2.6.3 It was agreed that the DMC should liaise with WGSCs with a view to formulating specific guidelines on media policy for 6 February and thereafter. The need for caution concerning public statements on Working Group meetings was noted, bearing in mind the importance of keeping leaks and speculation to a minimum.

2.6.4 It was agreed that no WGSC should act independently in this regard.

Action

2.6.5 **Media facilities for 6 February**

It was agreed that the Secretariat, in consultation with Security, will prepare a proposal for the DMC on this issue.

2.6.6 Procedure for first Working Group sessions

2.6.6.1 It was agreed that Working Group proceedings should commence at 10h30 as planned but that, following the convenors' opening remarks, each Working Group should adjourn not later than 11h00 for individual party briefings on relevant documentation, resuming proceedings not later than 11h30.

2.6.6.2 It was decided that the introduction of delegations should be added to the agenda.

2.7 It was agreed that the following matters should be carried forward to the next meeting of the DMC:

- * Financial assistance
- * Research pool

3. Security

3.1 As agreed at the previous meeting of the DMC, Col J Venter and Mr M Shaik were invited to present a proposal on security.

3.2 They informed the DMC that they had drawn in the co-convenors of the Security Task Group established for CODESA 1 (Maj PJ Nembambula and Mr R Mampane) in order to develop this proposal.

3.3 The proposal was approved, and it was agreed that the security grouping referred to therein will be known as CODESA Security (CS).

3.4 The meeting accepted the proposal that a political Committee on Security be established comprising the current co-commanders (Col J Venter and Mr R Mampane), the co-convenors of the Security Task Group, Mr M Shaik, Mr M Morobe (in his capacity as Head of Administration) and the Secretariat. It was agreed that this Committee should be constituted and function under the overall guidance of the DMC.

3.5 It was agreed that each participating party/organisation/administration in CODESA should be invited to provide a maximum of five persons to participate in the work of CODESA Security.

Action

3.6 It was agreed that the director of the World Trade Centre should be advised of the chain of command for CODESA Security and the underlying implications of this concerning security matters.

Action

3.7 It was noted that, in terms of the principle of equal participation,

each political party/organisation and administration is invited to send an appropriate representative to CODESA Security on the understanding that such a representative should participate in the practical arrangements for the security of CODESA. The invitation should not be seen as an opportunity for the broadening of party/organisation/administration delegations. It was decided that an appropriate letter should be sent to the heads of delegations in this regard.

- 3.8 Noting sensitivities and possible misperceptions concerning the ANC's and Government's joint command of CODESA Security, and with the principle of inclusivity in mind, it was agreed that the Subcommittee on Security should continue to function as proposed.

4. Chairmanship

- 4.1 Noting the merits of the principle of rotation whilst also bearing in mind the importance of continuity, efficiency and progress, it was agreed that P Gordhan should chair MC and DMC meetings up to and including the MC meeting scheduled for 10 February.

Action

- 4.2 It was agreed that the DMC should consider the following proposals in order to make specific recommendations to the MC when it next meets:

- * Dr Z de Beer and Mr P Gordhan to alternate as chairpersons of both committees.
- * Rotation on a broader basis.

- 4.3 The meeting agreed to examine the possibility of appointing a DMC member other than the current chairperson at the time of each MC and DMC meeting to interact with the media.

5. Applications to participate in CODESA

Action

5.1 Political organisations and parties

It was agreed that the administration should proceed with the gathering of information in this regard.

Action

5.2 Interest groups

The proposed response to applications in this category was approved.

Action

5.3 Traditional leaders

The proposed response to applications in this category was approved, subject to the inclusion of details on how interested parties will be afforded the opportunity to submit representations to the appropriate subcommittee.

5.4 **Observer status**

It was decided that this matter should be carried forward to the next meeting of the DMC.

6. **The next meeting of the DMC**

Action 6.1 This will take place in Cape Town on Tuesday 28 January at 13h00. DMC members will be informed of the venue, which should be neutral, in due course.

Action 6.2 It was agreed that travel arrangements should be made individually, but that the administration should co-ordinate transport from the airport to the appointed venue.

7. **Other urgent business**

7.1 It was agreed that the names of delegates serving on the five WGSCs should be released to the media immediately following the meeting.

7.2 It was noted that the matter of advertisements for submissions to Working Groups should be included in the agenda for the DMC meeting on 28 January.

8. **The meeting closed.**
