Dear Mr. Morobe:

I am writing on behalf of the <u>South Africa Constitution Watch</u> <u>Commission</u>, an independent, non-Governmental body formed in 1991 for the purpose of producing periodic reports on the positions of major parties in South Africa on constitutional developments and free elections as analyzed under the International Bill of Human Rights, including the Charter of the United Nations, the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights of 1966, the International Covenant on Social, Economic, and Cultural Rights of 1966, and related international human rights documents.

Whatever approaches the South African participants ultimately adopt toward a new democratic, non-racial society, the Watch Commission's periodic Reports and meetings we would like to schedule in South Africa in 1992 will hopefully be of assistance in bringing to the parties' attention the content and status of international human rights law, and encouraging maximum compliance with, respect for and promotion of those standards in the formulation and continuing modification of the positions held by those parties in the course of the negotiations towards a new constitution.


