Dear Alby


As arranged this morning I am letting you have the dates of the visit by Jack and Debby Greenberg to Cape Town.

They leave Durban for Cape Town on SA 625 which departs at 14h25 and arrives in Cape Town at ~~16h40~~ on Wednesday afternoon.
