### RECORDING AND TRANSCRIBING OF CODESA CONFERENCE 20 & 21 DECEMBER 1991

We thank you for the opportunity to tender for this important conference. The basic two page tender document has been completed and sent to your office by fax today. The purpose of this letter is to explain our quotation more fully - in particular the options we are able to offer - and to give you some insight into the ability and experience of Seemac in handling such important conferences.

#### DETAILS OF SERVICES OFFERED

## Recording the Proceedings of CODESA

- All sessions of your conference will be recorded using the specialised recording equipment. Provided at the World Trade Centre, with which we are fully au fait, having recorded and transcribed the South African Town Clerks Conference at this venue in 1990.
- 1.2 All tapes will be put into safe custody, as per your instructions.

  Should you or delegates require it, copies of tapes can be made and supplied at R350-00 per set. No tape copies will be made and/or supplied to other persons without your specific instructions.

### 2. Transcribing the Proceedings of CODESA

- 2.1 The verbatim transcript made from the tapes will be double checked for possible errors.
  Note that we will retain our relevant staff over the Christmas period to ensure that our Company's reputation for accuracy, presentation and rapid turnaround time will be maintained.
- 2.2 After checking and correcting, the transcripts will be paginated and a comprehensive index prepared for each volume. There will be two volumes, one for each day of the conference.
- 2.3 Copying will be done on the highest quality photostat machines, which are installed in our offices. We will not sub-contract out to any other company for copying/typing work.

  This is an important point not only from the confidentiality viewpoint, but also as outside companies cannot be relied on over the Christmas period.
- 2.4 Volumes will be staple and tape-bound so as to avoid the possibility of loose pages.
  Specially prepared front covers which include your CODESA logo will be used to bind the volumes.
- 2.5 Each front cover can be personalised (ie each delegate's title and name is printed on his/her volumes.) If you request this service we would require a full list of delegates names/titles before the start of the conference.
- 2.6 From our experience we would anticipate that each day of the conference will produce approximately 100 170 transcribed pages. Thus each set will comprise two such volumes, each of about 100 170 pages.
- 2.7 We have based our tender on the number of delegates being  $\pm 300$ .

## 3. Delivery of Transcripts

- 3.1 Regarding the supply to each delegate, we would offer two options:
  - We send to each delegate a set of the proceedings by courier.

    We would use DHL or Sun Couriers to effect delivery.

    Our quote does not include the courier's cost of, which would be charged to you separately. Only the actual courier cost would be charged to you, verified by the courier company's receipts.
  - 3.1.2 We deliver to your offices all sets of the proceedings.

    It would then be your responsibility to ensure that each delegate received them.

    Should you chose this option we would guarantee to deliver to your office on or before 6 January 1992.

    There would be no charge for the delivery of the sets to your offices.
