You will recall, I am sure, that a number of Christian organisations held a peaceful and orderly placard demonstration on Jones Street outside the gates of the World Trade Centre during Codesa 1. The purpose of the demonstration was to encourage participants to remember Biblical requirements for a new constitution.


