Organisation of the Archive as it corresponds to structures and processes of CODESA

1 The Archive is broadly divided into four categories:

- 1.1 CODESA 1 (from Preparatory Meeting on 28/29/30 November 1991 to first plenary session held on 20 & 21 December 1991) - indicated on storage boxes as C1
- 1.2 CODESA 2 (from early January 1992 to the second plenary session held on 15 & 16 May 1992) - indicated on storage boxes as C2
- 1.3 Post CODESA 2 (from 17 May 1992 until the suspension of meetings in late June 1992, and the period afterwards) - indicated on storage boxes as PC2
- 1.4 CODESA Various (banner, flag, poster, stickers and letterheads, bound volumes of documentation, membership lists, photographs, tapes, Stock Press press cuttings, etc) - indicated on storage boxes as CV

2 Within these broad categories, the Archive is divided into **sections** corresponding to the various administrative and process structures set up by CODESA during its development.

(NB: Where a structure was formed in the CODESA 2 period and continued to generate limited quantities of documentation after 16 May, all documents are archived, for the convenience of the user, under CODESA 2. Examples include: GAC, WG2, CODESA Administration and Correspondence, etc.)

2.1 The sections of **CODESA 1** are as follows:

- 2.1.1 Secretariat (an executive committee of 5 members, which was restructured as the 8-member DMC of CODESA 2)
- 2.1.2 Steering Committee (apart from the plenary, the most senior decision-making body of the CODESA 1 period; 19 members - 1 from each participant organisation). This body was expanded to become the Management Committee of CODESA 2 and the post CODESA 2 period
- 2.1.3 Task Group 1 (Organisation & Planning)
- 2.1.4 Task Group 2 (Drafting)
- 2.1.5 Task Group 3 (Process)
- 2.1.6 Administration & Secretarial Services

- 2.1.7 Convention Management (largely physical planning for the Plenary session)
- 2.1.8 Media Sub-committee (established in order to plan for the Plenary)
- 2.1.9 Protocol Sub-committee (established in order to plan for the Plenary)
- 2.1.10 Security Sub-committee (established in order to plan for the Plenary and remaining in force well after CODESA 2)
- 2.1.11 Incoming faxes for the CODESA 1 period
- 2.1.12 Outgoing faxes for the CODESA 1 period
- 2.1.13 Preparatory Meeting of CODESA (miscellanea which have survived the planning for this meeting held on 28, 29 & 30 November 1991)
- 2.1.14 First Plenary held on 20 & 21 December 1991
- 2.2 The Sections of **CODESA 2** are as follows:
 - 2.2.1 Management Committee (MC)
 - 2.2.2 MC Sub-committee investigating the participation in CODESA of the Zulu King and other Traditional Leaders (ZKTL)
 - 2.2.3 MC Sub-committee investigating the Declaration of Intent
 - 2.2.4 MC sub-committee investigating gender issues: Gender Advisory Committee (GAC)
 - 2.2.5 Daily Management Committee (DMC - comprising 8 MC members and acting as steering committee of the MC)
 - 2.2.6 Secretariat (a two-member body responsible, under the direction of the DMC, for the overall administration of CODESA. The members of the Secretariat were Mr Mac Maharaj and Mr SS [Fanie] van der Merwe)
 - 2.2.6.1 CODESA Correspondence (incoming correspondence together with responses - usually by Murphy Morobe, Head of CODESA Administration, are archived under Secretariat, as this body was ultimately responsible for the processing of such documents)

- 2.2.6.2 Organisations Applying to Participate in CODESA (Applications were processed and recommendations made by the Secretariat, although final decisions on all applications were reached by the higher authority of the MC. Applications were received from the CODESA 1 period, right through the CODESA 2 period.)

- 2.2.7 Working Group 1 (WG1 - Creation of a Climate for Free Political Participation), including its sub-structures:
 - 2.2.7.1 WG1 Steering Committee (WG1SC)
 - 2.2.7.2 WG1 Sub-group 1 (WGS1 - Completing the Reconciliation Process)

- 2.2.14 Security Sub-committee
- 2.2.15 Convention Management
- 2.2.16 Plenary held on 15 & 16 May 1992

2.3 The sections of **Post CODESA 2** are as follows:

- 2.3.1 Management Committee (documents of its remaining sub-committee, the GAC, archived still under CODESA 2)
- 2.3.2 Sub-committee 1 of the MC (MCSC1 - a sub-committee convened by the MC to further the tasks of the old WG1, after the suspension of WGs at CODESA 2 plenary) and its sub-structures:
 - 2.3.2.1 Task Group 1 (Political Prisoners)
 - 2.3.2.2 Task Group 2 (Security Legislation)
 - 2.3.2.3 Task Group 3 (Media)
 - 2.3.2.4 Task Group 4 (Refugees)

NB: Although reference is made to a TG4 in the first minutes of MCSC1, this TG was actually constituted outside CODESA, hence no documentation on it exists in this archive.

2.3.3 Sub-committee 3 of the MC (MCSC3 - convened by MC to further tasks of old WG3)

2.3.4 Sub-committee 4 of the MC (MCSC4 - convened by MC to further tasks of old WG4)

NB: Sub-structures (Standing Task Groups) were to be proposed by MCSC4 to the MC. However, negotiations were suspended in June 1992, before the MC had considered the matter.

2.3.5 Daily Management Committee

NOTES ON POST CODESA 2: The second plenary session agreed to suspend the WGs and to convene smaller MC sub-committees to continue work on which no agreement had been reached.

It was decided that no structure need be established to continue the work of WG5.

While a structure to continue the work of WG2 was intended, no such structure was established, owing to WG2's failure to reach consensus before the second plenary session. This item was on the agenda of the MC after CODESA 2, but negotiations were suspended before any decision had been reached.

MCSC1 was constituted out of the old WG1SC

MCSC4 was constituted out of the old WG4SC

MCSC3 was constituted out of the old WG3 Technical Sub-committee

3 Within each section, the documents are divided into **sub-categories**, which correspond, wherever possible, to the following:

3.1 Minutes and Agendas

3.2 Documents

3.3 Submissions

3.4 Correspondence

3.5 Miscellaneous

The above categorisation and organisational order has been preserved wherever possible and logical, although occasional exceptions occur, and some categories do not conform to all of the above sub-categories.

The category CODESA Various does not conform to the above, owing to the different nature of the material. Here each box has an individual index and the contents of the box are indicated on its label.

Physical Organisation of Archival Material

4 Within the categories, sections and sub-categories, material is physically divided into storage boxes and folders. Each box and folder is labelled on the outside.

5 The boxes are numbered from 1 to 110, beginning with CODESA 1, Secretariat, Minutes and Agendas, Folder 1 and ending with CODESA Various, Photographs File 3, Box 110. They thus imitate the structures outlined in points 1, 2 & 3 above. (See attached Appendix A: List of Contents, for a broad indication of the contents of each box.)

Some large sections occupy more than one storage box (eg, the WGs, Plenary Sessions, etc)

Each box is labelled with the following:

Category (eg, C1)

Section (eg, Task Group One)

Date period covered (eg, December 1991)

Box number

Folders contained in the box

6 Each section has an index which is included in every box pertaining to that section.

The index is labelled at the top with:

INDEX

Category (eg, CODESA 1)

Section (eg, Steering Committee)

All sub-categories included in this section (eg, Minutes and Agendas, Documents, Correspondence and Miscellaneous)

Date period covered by this section (eg, December 1991)

It then lists all folders included in the section, together with the contents of each folder. The folders are grouped under their sub-categories: ie, if sub-category 1 is Minutes and Agendas and five folders exist, these will be itemised as 1.1, 1.2, 1.3, 1.4 and 1.5. The folders of category 2 Documents will be itemised as 2.1, 2.2, etc

7 Each folder has a cover sheet which indicates:

Category (eg, CODESA 2)

Section (eg, WG2) & Folder Number (eg, 1)

Sub-category covered by that particular folder (eg, Minutes and Agendas)

It then lists all items included in the folder. The cover sheet may include notes to the researcher (these notes are not usually repeated on the index)

8 Owing to the duplication of documents in different areas of the archive, it was not felt necessary or advisable to assign a number to every document. Thus, the numbers used on index and cover sheets for a single document do not usually correspond: they are used purely according to the internal logic of the index list or cover sheet list. However, the names of categories, sections, sub-categories, box numbers and folder numbers always correspond and it is using these tools that the researcher will trace a document within the Archive.

Numbering systems have been kept as simple as possible. However, in the section of C2 covering WG4 and the tapes section under CV, subsidiary numbering (a, b, c, etc) has been used in the numbering of folders and boxes. This is because large quantities of material were found after completion of organisation of the archive, and an attempt was made to incorporate this material without disrupting the rest of the archive's structure.

CODESA

Suggested approach for the researcher with limited orientation

The following documents are recommended for preliminary research and understanding of the processes, structures and mechanisms of CODESA:

- 9.1 CODESA 1 minutes of Steering Committee, Task Groups 1, 2 & 3
- 9.2 CODESA 1 Transcript (Vols I and II) and Documents as agreed by the First Plenary Session (Declaration of Intent, Standing Rules for Plenary Sessions of CODESA, Agreed Terms of Reference for the Working Groups of CODESA)
- 9.3 CODESA 2 Tasks of the MC (MC Document), minutes of the MC, minutes of the DMC, minutes of the WGs and WG Steering Committees, Tasks of the Secretariat and Secretariat reports (Secretariat Documents)
- 9.4 CODESA 2 Working Documents (Vols 1 and 2), CODESA 2 Transcript (Vols III and IV) and Documents agreed by the Second Plenary Session (Resolutions, revised Declaration of Intent).

NB: Although WG2 did not compile a report for the CODESA 2 Working Documents, a memorandum on discussions in WG2 was submitted to the MC in the Post CODESA 2 period. This document will be found in PC2 MC Folder 3 (box 80).

- 10 The CODESA Administration Archive was compiled from material gathered by CODESA Administration from its records. Additional material may be available from participant organisations and delegates, organisations who submitted documents to the Working Groups, press reports and photographs, etc.
