WORKING GROUPS' FOCII: TERMS OF REFERENCE

GROUP I

i. Creation of a climate for the free political participation;

- give guidelines as to methods to be adopted to foster spirit of tolerance amongst the participating parties,
- determine possible co-ordination of workings of National Peace Accord Committee with an envisaged Peace Secretariat established in terms of this Working Group,
- recommend possible codes of conduct to be observed by all parties in order to achieve a climate conducive to a free and democratic participation.
- ii. Role of International Community;
 - recommend guidelines as to a role to be played by International Community,
 - possible participation by International Community to give credibility and support to resolutions/decisions arrived at during the meeting of CODESA,
 - determine possible financial assistance by International Community to CODESA,
 - role to be played by International Institution to oversee the transition of permanent Constitutional process in South Africa and to make recommendation to other matters related thereto.

GROUP II

X iii. General Constitutional principles;

- give guidelines on Constitutional Principles on which the Constitution of the country can be based,

iv. Constitution making body/process;

- give guidelines as to the composition of Constitution making body/process based on democratical principles,
- determine extent of powers of a Constitution making body/process and the enforcibility of its decisions,

- make recommendation thereupon to CODESA.

Future role of traditional leaders;

- possible guidelines as to a role to be fulfilled by the traditional leaders in the workings of CODESA,
- determine a need for an involvement of traditional leaders to CODESA,

- give/ make recommendation on these and other related matters to CODESA.

GROUP III

vi. Transitional arrangements/Interim Government/transitional authority;

- investigate best/suitable transitional arrangement/Interim authority based on democratical principles and which will be credible to the people of South Africa,

- give guidelines regarding the composition of that body,
- how the transitional arrangement can be accomplished with minimum interruption to the obligations and relations of the country with international Governments/or financial institutions.

GROUP IV

- vii. Future of TBVC States;
 - investigate the desirability of reincorporation of TBVC States into South Africa and the logistics thereof,
 - give guidelines to substitutional arrangements without any serious prejudice to citizens of those states and matters related thereto and to make recommendations in this regard to CODESA.

GROUP V

viii. Time frames;

- give guidelines to a time table regarding operation of CODESA before and after constitutional settlement and to make recommendations thereto.
- ix. Implementation of CODESA's decision;
 - give guidelines as to the enforcibility of the decisions of CODESA,

- possible remedies to redress any transgression of those decision,

- establishment of CODESA monitoring committee to oversee the implementation of decisions thereof and to report on progress made to CODESA or the Steering Committee,
