PRESS RELEASE BY MR JUSTICE R.J.GOLDSTONE, CHAIRMAN OF THE
COMMISSION OF ENQUIRY INTO THE PREVENTION OF PUBLIC VIOLENCE
AND INTIMIDATION

On 3 and 4 December 1991 serious violence erupted in Bruntville, Mooi River. The Commission has decided that the causes of that violence should be investigated by it. A Committee of the Commission was recently established to enquire into the conduct of public demonstrations. That Committee will in addition enquire into the aforementioned events in Bruntville. It consists of myself as chairman, Advocate N.Rossouw, SC, the Vice-Chairman of the Commission and Professor D.Van Zyl Smit, the Dean of the Law Faculty at the University of Cape Town.

Evidence will be heard by the Committee in public at the Mooi River Town Hall from 14 January 1992 at 0700. Interested parties may be represented at the enquiry. Submissions, or statements of witnesses who may have relevant information should be submitted by not later than 10 January 1992 to:

**PERSVERKLARING DEUR SY EDELE REGTER R J GOLDSTONE, VOORSITTER VAN
