#### 5. THE PROCESS

Mac Maharaj led discussion on the process and made the following comments.

- 5.1 Position of the Negotiating Commission is to complete the process before the end of August 1993. Time is of the essence and the negotiating team is working under considerable constraint.
- 5.2 The question to be asked is "Can we live with the changes".
  - 5.2.1 We should look at the package as a whole. If we tamper with the package, we open up discussion.
  - 5.2.2 Various views were expressed on elections and voting.
- 5.3 Regional Constitution could be devisive.
- 5.4 The Constitution-making body should elect its own Chairperson.

#### 6. COMPETITION OF DRAFT CONSTITUTION

It was agreed that Arthur should use our own Constitutional formulation to complete the rest of the draft Constitution of the Technical Committee.

#### 7. SIXTH REPORT ON FUNDAMENTAL RIGHTS

Albie and others prepared a response to this report which was presented to the Technical Committee. It was agreed that we should wait for the seventh report and thereafter meet and discuss such report with other people involved. We should then prepare a further response.
