MINUTES OF THE MEETING OF THE MANAGEMENT COMMITTEE HELD AT THE WORLD TRADE CENTRE ON MONDAY 27 APRIL 1992 AT 16H45 AND ON TUESDAY 28 APRIL 1992 AT 13H30.

1. **Chairperson's opening remarks**

The members were welcomed and made aware of the full program of discussion facing the meeting. The Chairperson appealed for co-operation to enable the meeting to close timeously at 19h00. It was noted that a press briefing was scheduled for 18h30 for any aspects emerging from the meeting.

2. **Apologies**

The apologies were noted.

3. **Agenda**

3.1 It was noted that, under Item 5.6, matters affecting Codesa 2 not listed elsewhere, could be raised.

3.2 The agenda was adopted with no amendments.

4. **Ratification of the minutes of the meeting of 30 March 1992**

The minutes were ratified with no amendments.

5. **Codesa 2**

5.1 It was noted that Codesa 2 has been under discussion at DMC meetings and logistical arrangements are already underway in respect of preparations for Codesa 2.

5.2 It was noted that Item 5.1 of the agenda had been put there in order to remind the MC of matters requiring attention per decisions of Codesa 1, to attend to these items.

5.3 Declaration of Intent:

It was agreed that the issue of the "commitment" aspect would be revisited at the next DMC meeting and, if necessary raised at the next meeting of the MC.

5.4 Applications to join Codesa:

The DMC presented its recommendations in the form of a report prepared by the Secretariat. The meeting agreed as follows:

5.4.1 The MC reject the applications of 8 of the organisations which had not responded to the questionnaire for reasons indicated in the report.

5.4.2 Of the remaining 9 applicants, which had replied to the questionnaire, it was agreed to reject 7 of them. The application of FIDA was rejected by sufficient consensus.

5.4.3 With regard to the application of the Peoples Progressive Party of South Africa and the National Seoposengwe Party, the matter was referred back to the DMC for further consideration with a view to bringing a recommendation to the next MC meeting.

5.4.4 FT Mdlalose agreed to withdraw the Joint Executive Authority of Kwazulu/Natal application. The issue of the Joint Executive Authority of Kwazulu/natal would be discussed within the DMC.

5.4.5 It was agreed that the press would be informed of the above decisions as soon as letters had been sent out to the respective applicants.

6. **Sub-committee on the Zulu King and other Traditional Leaders**

6.1 The final report and recommendations from the sub-committee was presented to the MC.

6.2 The two options regarding the form in which the King of the Zulus and other Traditional Leaders could be afforded participation in Codesa was considered.

6.3 Arising out of the discussions a third option was placed before the meeting.

* The four delegations will have the right to participate in the plenary sessions

* They will have a similar right to participate in the Working Groups

* Recognising that the Traditional Leaders have a vital role in guiding and unifying our people, which is made possible by standing above party politics and concentrating on

the general interest of the nation, the standing rules remain with regard to reaching agreement.

- * In keeping with the above, the delegations of the Traditional Leaders would participate in the structures of Codesa as decided by Codesa 2.

- 6.4 The meeting was adjourned at 19h00 and reconvened at 13h30 on 28 April 1992
- 6.5 After discussion it was agreed that due to lack of consensus, all members of the MC would consult their principals on the 3 options. The matter would be revisited at the next MC meeting.
- 6.6 It was further agreed that the sub-committees report as well as the document setting out the third option would be released to the press through the MC Chairperson. Delegates were urged to conduct themselves in a constructive way with the press on this matter and that they do not issue statements which would harm the debate.

7. Codesa 2

7.1 Structure of the Agenda:

The matter was referred to the DMC for recommendations. All MC participants could submit recommendations to the DMC.

7.2 Working Group Preparations:

The following was noted:

- 7.2.1 Working Groups need to orientate themselves for Codesa 2
- 7.2.2 MC members were urged to ensure that Working Groups adequately prepare for Codesa 2.
- 7.2.3 The DMC would follow this matter up in its meeting with Working Group Steering Committees.

7.3 Other Preparations:

- 7.3.1 The suggestion that a Protocol Committee as for Codesa 1 be appointed, was referred to the DMC.
- 7.3.2 The DMC was asked to report to the next MC meeting with regard to opening prayers for Codesa 2.
- 7.3.3 The principle of parallel/simultaneous translation of the different languages into English at Codesa 2, was agreed upon. It was further agreed that the DMC and the Secretariat would explore the logistics in this regard and report back to the MC for a final decision to be taken.

8. GAC Sub-committee

Noting that the DMC had met the GAC on two occasions, that the Chairperson of the DMC had met the Chairperson of the GAC, and further noting the requests from the GAC, it was agreed that:

- 8.1 The Terms of Reference of the GAC be amended to allow each participating organisation one delegate plus one adviser.
- 8.2 Substitution would be allowed.
- 8.3 All participants take steps to ensure adequate representation of women within their delegations from Codesa 2.

9. Working Group Progress

It was noted that the DMC was scheduled to meet with the Working Group Steering Committee's after the MC meeting of 28 April 1992 in this regard.

10. Media and Marketing

The following was noted:

- 10.1 The DMC and the Secretariat are attending to these matters.
- 10.2 The media sub-committee had its first meeting on 28 April 1992.
- 10.3 The Chairperson has been requested to appear on talkshows.
- 10.4 The Secretariat is to submit a report on the "Marketing of Codesa".

11. Any other business

- 11.1 Correspondence on the issue between Paramount Chief Sandile and the Ciskei Government:

It was agreed to refer this issue to the delegate from the Ciskei Government on the MC with a view to resolving the matter within the Ciskei. It was further agreed that the Ciskei delegate would furnish the next meeting of the MC with a report.

- 11.2 Report from the delegation sent to observe the British Elections:

A report will be drafted by the delegation and would be forwarded to members of the MC.

12. Future meetings

- 12.1 MC Meeting : Monday 4 May 1992 at 18h00 to specifically discuss and conclude the issue of the participation of the Zulu King and other Traditional Leaders in Codesa.
- 12.2 MC meeting : Thursday 7 May 1992 at 17h00 to 20h00 in Cape Town.
