# RESOLUTIONS DISCUSSED/ADOPTED AT NEGOTIATING COUNCIL MEETINGS

# 1. Draft Motion on Violence (Addendum A)

- "To recommit ourselves personally and collectively to peace; and undertake effective action, jointly and severally, leading to the eradication of violence and the attainment of peace".
- 1.2 "To call on our followers and members to desist from any form of violence or intimidation and to give the negotiations .....".
- 1.3 "to do everything in our power to strengthen the National Peace Accord and its structures".

# Declaration on Cessation/Suspension of Hostilities, and Violence (Addendum H, and I)

- 5.1 "That participants in the Negotiating Process have a responsibility to inculcate a new spirit of tolerance".
- 5.2 "That political rivalry and competition does not require the use of violence".
- 5.3 "That it is necessary for all participants to eschew violence in all forms".
- 5.4 "There is a need for cessation/suspension of hostilities/armed struggle/violence for peaceful negotiations to move forward".
- 5.5 "That as from this 18th day of June 1993 we, the parties subscribing to this Declaration, commit/recommit ourselves to peaceful resolution of conflict and where applicable cease/suspend any form of hostilities/armed struggle/violence in pursuance of political objectives and in the resolution of political differences and further ensure that the conduct and utterances of all are consistent with this Declaration".
