MINUTES OF THE FIRST MEETING OF WORKING GROUP 2 HELD AT THE WORLD TRADE CENTRE ON MONDAY 20 JANUARY AT 10H30.

Present: Delegates and advisers (see Addendum A) Z Titus (Chair) M Phillips (Secretary) S Mkhabela (Minutes)

1. Convenor's opening remarks

The meeting was chaired by Mr Z Titus on behalf of the Daily Management Committee (DMC).

In his opening remarks the Chairperson made the following proposals on behalf of the DMC:

- 1.1 The Working group should elect its own Chairperson.
- 1.2 No person currently serving on the DMC should be Chairperson of any Working Group.
- 1.3 The terms of reference of the Working group are open-ended and delegates should be free to broach any issue relevant to the group's work.
- 1.4 The Working group is expected to furnish a progress report by the end of March ahead of CODESA 2.
- 1.5 Decision making shall be by consensus alternatively, sufficient consensus, in accordance with CODESA's rules of procedure.

These proposals and remarks were unanimously accepted.

Documentation was distributed to all delegates and advisers. The documents were labelled as follows:

The agenda was adopted with the proviso that items 5.1 and 5.2 be deferred until the Working group is fully functional.

4. ESTABLISHING THE MECHANISMS/STRUCTURES TO FACILITATE THE FUNCTIONING OF THE WORKING GROUP IN ACCORDANCE WITH THE GUIDELINES

The meeting considered the proposals in the additional guidelines on the convening and chairing of Working Group meetings, and the establishment of a Working Group Steering Committees.

4.1 ESTABLISHMENT OF STEERING COMMITTEES

The following was agreed :

4.1.1 The Steering Committee shall consist of 8 members;

4.1.2. The Chairperson(s) of the Working group shall be chosen from among the Steering Committee members, by the Steering Committee itself.

Solidarity expressed reservations with the decision not to be able to choose chairpersons from outside the Steering Committee.

4.2. MEMBERSHIP OF STEERING COMMITTEE

The meeting decided on the basis of sufficient consensus that the Steering Committee shall consist of:

Dr J T Delport; Mr C W Eglin; Advocate P Holomisa Mr M J Mahlangu Mr M V Moosa Dr B S Ngubane Mr M Richards Mr J Slovo

This steering Committee shall operate until CODESA 2 has been held, at which point the Committee's membership shall be reconsidered.

It was also decided that the Steering Committee should meet immediately at the end of the Working Group meeting to appoint a convenor and to decide the dates of its meetings.

Reservations regarding the method of selection of the Steering Committee were expressed by the Dikwankwetla Party, the Labour Party and the Bophuthatswana government.

4.3. FUNCTIONS OF STEERING COMMITTEE

4.3.1. To prepare agendas;

- 4.3.2. To formulate a media strategy ;
- 4.3.3. To consider the establishment and programmes of subgroups;
- 4.3.4. To consider the Additional Guidelines with regard to the need for a rapporteur;
- 4.3.5. To nominate a chairperson/chairpersons for Working group meetings;
- 4.3.6. To discuss methods of inviting and handling submissions by interested groups to the Working Group.
- 4.3.7. To determine a procedure by means of which every Working Group member may contact every other Working Group member;
- 4.3.8. To make recommendations on the form and content of Working group minutes;
- 4.3.9. To identify any other function it may need to perform.

5. TERMS OF REFERENCE OF THE WORKING GROUP

Items 5.1 and 5.2 were referred to the Steering Committee for further consideration.

5.1 Meetings

Re: Item 5.3 of agenda on the Working Group programme the following was decided:

- 5.1.1. The next meeting of the Working group shall be held on 6 February 1992 at 10h00;
- 5.1.2. A further meeting of the Working group shall be held on 11 February 1992 at 10h00;
- 5.1.3. The Working Group shall thereafter meet every Monday and Tuesday. All Monday meetings shall start at 10h00;
- 5.1.4. All delegates and advisers whose existing schedules are affected by the agreed schedule of Working Group meetings should make the necessary adjustments to their schedules.
- 6. METHODS OF HANDLING SUBMISSIONS BY INTERESTED GROUPS

The meeting accepted the proposal set out as point 5 of the Additional Guidelines but amended the last sentence of 5.1.3 to read as follows:

"Such determination could be made by the Working Group, subject to the advice of the Steering committee".

7. CLOSURE

7.1. It was agreed that delegates and advisers should receive documentation in advance of meetings in future;

7.2. and that improved seating arrangements would be provided;

7.3. and to provide microphones for all meetings.

Dr G Viljoen gave a vote of thanks for the day's proceedings and the meeting was officially closed by Mr Titus at 15h40.
