GENERAL CONSTITUTIONAL PRINCIPLES AND CONSTITUTION
MAKING BODY / PROCESS

1. WHITE HISTORY

BY VIRTUE OF WHITE HISTORY, CULTURE, CONTRIBUTIONS AND BIRTHRIGHT IN S.A. THE WHITE MAN CANNOT BE WRITTEN OUT OF EXISTENCE. REALISTICALLY AND REASONABLY IT HAS TO BE ACCEPTED THAT WHITE, EUROPEAN, WESTERNIZED CULTURE AND BIOLOGICAL MAKE-UP IS DIFFERENT RADICALLY FROM BLACKS AND OFTEN AHEAD OF BLACKS. AS SUCH WHERE WHITES WISH TO RETAIN THESE DIFFERENCES THEY HAVE EVERY RIGHT TO DO SO BY VIRTUE OF THEIR HISTORICAL STAKE IN SOUTH AFRICA.. SIGNIFICANTLY THE A.N.C. / P.A.C. TENDENCY THUS FAR HAS BEEN TO DISCRIMINATE AND BLACKMAIL WHITES IN THE CULTURAL AND SPORTING SPHERES.

2. CODESA, THEREFORE, CANNOT TAKE AWAY THIS RIGHT AND IT IS IN FACT LUNACY FOR CODESA TO AIM TO DO THIS. FOR A UNITARY S.A. WHICH IS CODESA'S GOAL WILL IN FACT ATTEMPT TO REMOVE WHITES' RIGHTS OF SELF DETERMINATION

3. THE A.N.C. APPROACH IS LARGELY A NEGATIVE
POLITICAL ONE. INFLAMMATORY STATEMENTS
ANTICIPATE A WINNER-TAKE ALL A.N.C. MAJORITY
RULE. THE DEMOCRATIC PARTY CONSISTENTLY SUPPORTS
THIS APPROACH AS DOES THE N.P. AS THEY
ARE APPARENTLY BOTH PRESSURIZED INTO DOING
SO. THIS GIVES WHITES THE FEELING THAT THEY
ARE BEING BETRAYED AND UNDERMINED. THE
PACKING OF COESA WITH A.N.C. - SUPPORTING PARTIES
DOES NOT BODE WELL.

4. TO MOST WHITES IT IS ANATHOMA THAT THEIR
SUPERIOR CULTURE BE SUBMERGED IN THAT OF
BLACK AFRICA AS THE A.N.C. SEEM TO INTEND.
THIS WILL SERVE NO PURPOSE TO S.A. OR AFRICA.

5. BLACK SELF DEVELOPMENT. BLACKS CANNOT EXPECT
THE WHITE MAN TO CARRY THEM FOREVER OR VICE-VERSA.
THEY MUST STAND ON THEIR OWN FEET.
THEY CANNOT EXPECT WHITES TO SACRIFICE
THEMSELVES. WHITE CHILDREN OF AFRICA AND GOD HAVE
NO CONSCIENCE AS THEY WERE BORN TO A SITUATION
NOT OF THEIR MAKING AND ALSO BLACKS FAILED TO
DO MUCH FOR THEMSELVES IN SPITE OF APARTHEID.
IRONICALLY MOST BLACKS DEVELOPED UNDER THE WHITES

6. DIFFERENT PATHS, DIFFERENT BIRTH RATES

PARTICULARLY BECAUSE BLACK NUMBERS WILL SWAMP WHITES AND OUR PATHS ARE SEPARATE, OUR RATES OF DEVELOPMENT SEPARATE AND DIFFERENT. THAT IS THE REALITY OF S.A. WE CANNOT BE TOGETHER IN ONE STATE.

7. THE NEW CONSTITUTION MUST BE VOTED UPON BY EACH POPULATION GROUP BEFORE ANY POWER IS TRANSMITTED FROM PARLIAMENT. EACH POPULATION GROUP MUST BE ABLE TO LOOK INTO THE FUTURE CONSTITUTION AND SEE THAT ITS CULTURE, EXISTENCE, SECURITY IS TOTALLY ENSURED AND THAT THERE IS NO POSSIBILITY OF DOMINATION BY ANY OTHER ETHNIC / CULTURAL GROUP. 1.
