MINUTES OF THE SECOND MEETING OF WORKING GROUP 4 (THE FUTURE OF THE TBVC STATES) HELD AT THE WORLD TRADE CENTRE ON THURSDAY 6 FEBRUARY 1992 AT 10H50

#### 1. Chairperson's opening remarks

1.1 The Chairperson explained that she was chairing in the place of Dr Mdlalose for continuity, as Dr Mdlalose had been ill and unable to attend the Working Group Steering Committee 4 (WGSC 4) meeting of 27 January 1992.

#### 2. Minutes

- 2.1 The minutes of the first meeting of Working Group 4 (WG 4) were adopted with corrections.
- 2.2 It was noted that WGSC 4 minutes are submitted to the WG 4 for information only, not for adoption.

#### 3. Agenda

- 3.1 The agenda for the WG 4 meeting of 6 February 1992 was drafted by the WGSC 4 on 27 January 1992.
- 3.2 It was agreed that at the next meeting of WG 4 on 10 February 1992, the issue of "Consensus" and the principle of reincorporation be discussed.

#### 4. Reincorporation/Opening Statements

- 4.1 The Chairperson requested that the opening statements of, firstly, the TBVC States and the South African Government and secondly, by any other parties who wanted to state their positions, be made.
- 4.2 It was agreed that each party would just state their position on reincorportion and no discussion/debate would follow.

#### 6. Research

It was agreed that the question of research and the advertisements to be placed, could not be properly addressed until the debate on the opening statements on reincorporation had been completed. This debate is to be part of the agenda for the next WG 4 meeting on 10 February 1922.

## 7. Formation of sub-committees and discussion thereof

It was agreed that the formation of sub-committees should be delayed until the debate on the opening statements on the principle of reincorporation had been completed. This would equip WG 4 with the information necessary to form the necessary sub-committee's.

#### 8. Frequency and dates of future meetings

It was agreed, in principle, that WG 4 would meet on Mondays and if necessary on Tuesdays. Guidance would be required on this point by the WGSC 4. A decision on whether it is necessary to meet on Tuesday 18 February 1992 will be made on the meeting of WG 4 on Monday 10 February 1992.

#### 9. Rapporteurs

It was suggested that the question of rapporteurs be delayed until the debate on the opening statements on reincorporation has been completed. It would then be clearer to WG 4 what type of persons are needed as rapporteurs. (The additional guidelines (Addendum C) were referred to with reference to what is expected of a rapporteur.)

# 10. Confirmation of next meeting of WG 4

It was confirmed that the next meeting of WG 4 will be on 10 February 1992 at 10h00 at the World Trade Centre.

#### 11. Closure

- 11.1 The Chairperson then closed the meeting.
- Working Group members were asked to leave name tags for the Administration.
