

PRESS RELEASE BY THE HONOURABLE MR JUSTICE R J GOLDSTONE, CHAIRMAN OF THE COMMISSION OF INQUIRY REGARDING THE PREVENTION OF PUBLIC VIOLENCE AND INTIMIDATION

1. There is mounting concern regarding the tension and conflict occurring in the taxi industry at Rustenburg. The Commission has acceded to requests to institute a preliminary inquiry.
2. Consequently, two members of the Commission, Advv D J Rossouw and M N S Sithole, will hold a public preliminary inquiry at 10 am on Friday, 24 September 1993, in the Community Hall, corner of Phlox and Sackville Streets, Karlien Park, Rustenburg. The committee will investigate the nature and causes of the conflict and consider recommendations on the steps that are necessary to prevent further violence; and whether a justice of the peace may play a role. The committee will hear representations from interested parties.

1. Daar is toenemende besorgdheid oor die spanning en konflik wat in die taxibedryf in Rustenburg heers. Die Kommissie het besluit om te voldoen aan versoeke om 'n voorlopige ondersoek in te stel.
2. Gevolglik sal twee lede van die Kommissie, naamlik advv D J Rossouw en M N S Sithole, as die komitee wat openbare geweld en intimidasie in die taxibedryf ondersoek, om 10 vm op Vrydag, 24 September 1993, in die Gemeenskapsaal, hoek van Phlox- en Sackvillestrate, Karlienpark, Rustenburg 'n openbare voorlopige ondersoek hou. Die komitee sal die aard en oorsake van die geweld ondersoek en voorstelle oorweeg oor welke stappe geneem moet word om verdere geweld te voorkom; en óf 'n vrederegter 'n rol in hierdie verband mag vervul. Die prosedure sal wees dat die komitee voorleggings van belanghebbendes sal aanhoor.
