SOUTH AFRICAN SCENARIOS

During 1990 and early 1991 a series of scenarios for South Africa to 1995 were developed through a process sponsored by the SA Mutual Life Assurance Association (Old Mutual) and the Nedcor Group.

The scenarios were presented initially to the Cabinet, leadership of many political groupings and parties, trade unions, church and business leaders, civic associations and the interested public. Since the first presentation in January 1991, more than 45 000 South Africans have attended the 3-4 hour presentations, as well as audiences in France, Germany, the United Kingdom, Kenya, Switzerland and the United States.

A short while ago, an approach was made to the Codesa Management Committee by Dr John Maree on behalf of both sponsors, offering to make available a 90 minute, updated scenario presentation to all participants in Codesa. The Management Committee agreed to facilitate this invitation extended by the sponsors to delegates at Codesa. The presentation will be made at the Airport Holiday Inn on the evenings of 10 and 11 May from 19h30 - 21h30, including discussion time. The presenters will be pleased to remain longer to discuss specific issues with interested persons.

The presentation team will include: Dr Mamphela Ramphele, Deputy Vice-Chancellor of the University of Cape Town, Dr GS (Andy) Andrews, former Dean of the Wits Business School and now independent management consultant, Professor Willie Esterhuyse, Professor of Political Science at the University of Stellenbosch and Dr Robin Lee, Director Robin H Lee Associates.
