MINUTES OF THE TWELFTH MEETING OF THE STEERING COMMITTEE OF WORKING GROUP 4 (THE FUTURE OF THE TBVC STATES) HELD AT THE WORLD TRADE CENTRE ON TUESDAY 5 MAY 1992 AT 16H00

1 Opening by chairperson

The chairperson requested Mr JM Matsana to chair the meeting.

2 Adoption of minutes of WGSC 4 meeting of 27 April 1992

The minutes of WGSC 4 meeting of 27 April 1992 were adopted.

3 Matters arising from minutes of WGSC 4 meeting of 27 April 1992

There were no matters arising.

4 Report-back from meeting of DMC and two representatives of each WGSC held on 28 April 1992

- 4.1 The report-back had already been given in the plenary session of WG 4. Mr Abrahams added that there would be a further meeting on Monday 11 May 1992 at 12h30. It was agreed that Ms SN Sigcau and Mr T Abrahams would represented WGSC 4 at the meeting.
- 4.2 Mr T Abrahams pointed out that with respect to areas of overlap between working groups, whatever is agreed by one arm of Codesa is binding and cannot be undone.

5 Report from sub-group 3 to Working Group 4

The amended report of sub-group 3 to WG 4 was circulated to the steering committee. Delegates were requested to check the amendments as agreed in WG 4.

6 Report to Codesa II

6.1 <u>It was agreed</u> that the following documents would form the basis of the report to Codesa II:

- 6.2 <u>It was further agreed</u> that the secretary of WG 4 and the rapporteurs would compile a draft report, which would then be faxed to leaders of delegations with the request that comments be received at Codesa by noon on Friday 8 May 1992. Delegations will be asked to acknowledge receipt of the fax and those who do not do so will be followed up.
- 6.3 WGSC 4 will meet again on Friday 8 May 1992 at 14h00 in order to consider the comments received and prepare the final report for Codesa II.
- 6.4 WGSC 4 will decide at the meeting on 8 May who will answer questions on the report of WG 4 at Codesa II.
- 6.5 It was noted that the SA Government delegation has yet to receive a reply from their principal regarding the report of the task group. This will be communicated to Ms S Albertyn on Wednesday 6 May 1992.

7 Discussion of comments by WG 3 delegates in joint meeting of WGSC 3 and 4 on 24 March 1992

It was agreed that this matter was no longer relevant as WG 4 had reached agreement.

8 Closure

The chairperson expressed thanks in advance for the work that would be done by the secretary and the rapporteurs on compiling a draft report for Codesa II. The meeting was closed at 17h15.
