It was agreed that the amended Draft Report will be presented by the Rapporteur at the next meeting of Subgroup 3 for further discussion.

It was agreed that the way in which the Rapporteur's report was discussed and reformulated represented a good basis for a report to the Working Group 4 Plenary Session.
