We recognise though, that pragmatism has to be a consideration in effecting a smooth transition from the present reality to one which is envisioned by a majority of participants in Codesa.

We also hold the view that the economic burden, presently supported by the fiscus in keeping the various structures in place, must receive priority in our consideration and debates. The longer such structures exist, the longer they will stragulate expenditure on education and health amongst others.

As we stand for an erosion of present structures to allow for a smooth transition to a new widely supported structure, aspects relating to the training and the future of civil servants and government employees amongst others must start receiving attention separately but on parallel tracks with our other discussions. The consideration of one will have a direct bearing on the other.
