**MINUTES OF THE ELEVENTH MEETING OF THE STEERING COMMITTEE OF WORKING GROUP 4 (THE FUTURE OF THE TBVC STATES) HELD AT THE WORLD TRADE CENTRE ON MONDAY 27 APRIL 1992 AT 16H10**

**1 Opening by Chairperson**

The chairperson welcomed delegates to the meeting. Mr T Abrahams was requested to chair the rest of the meeting. Mr Abrahams expressed his support for the sentiments expressed by Mr Phosa viz. that the credibility of Codesa is at stake if working groups do not deliver concrete proposals at Codesa II.

**2 Agenda**

The agenda for the meeting was adopted. It was however decided to advance item 6 viz. establishing dates and times of meetings of WG 4 and sub-groups to item 3.

**3 Establishing dates and times of meetings of WG 4 and sub-groups**

3.1 It was reported to the meeting that sub-group 4 had decided not to meet on 28 April, and would meet instead on the day following the next meeting of WG 4.

3.2 It was agreed that WG 4 would meet at 10h00 on Monday 4 May and Tuesday 5 May 1992. The sub-groups would meet after the plenary meeting on Tuesday, if necessary.

**4 Adoption of minutes of WGSC 4 meeting of 21/22 April 1992**

The minutes of WGSC 4 meeting of 21/22 April 1992 were adopted.

**5 Matters arising from WGSC 4 minutes of 21/22 April 1992**

Point 4.2: The DMC has still not responded to the request that it raise the transport claim allowance.

**6 Matters arising from WG 4 minutes of 27 April 1992**

Mr Meyer referred to his request in the meeting of WG 4 that the remarks made by WG 3 delegates in the joint meeting of WGSC 3 and 4 be placed on the agenda of WGSC 4.



7 **Agenda for next meeting of WG 4**

It was agreed to place the following items on the agenda:

- Discussion of rapporteurs report and other position statements
- Report to Codesa II
- Future of sub-groups 1 and 2
- Comments, if any, on submissions received to date

8 **Report of WG 4 for Codesa II**

8.1 It was agreed to ask the secretary of WG 4 and the rapporteurs to suggest a framework for the report to Codesa II.

8.2 Delegates drew up the following preliminary outline:

- Terms of Reference of WG 4
- Decision to break into sub-groups
- Report-back from sub-groups
- Participation of TBVC states in interim arrangements

8.3 It was agreed that the two members of WGSC 4 nominated to attend the meeting with the DMC on 28 April advise the DMC of the above suggestions regarding the report of WG 4 to Codesa II.

9 **Nomination of two members of WGSC 4 to attend meeting with the DMC on 28 April 1992**

It was agreed that Ms SN Sigcau and Mr AT Meyer would represent WGSC 4 at the meeting with the DMC.

10 **Date and time for next meeting of WGSC 4**

It was agreed that WGSC 4 would next meet immediately after the meeting of WG 4 on Monday 4 May 1992.

11 **Press release**

Delegates were advised that the media had obtained copies of the rapporteurs report. It was agreed that WGSC 4 should issue a press release stating that the rapporteurs report is still the subject of debate and that parties are consulting their principals regarding the report.

The text of a press release prepared jointly by Mr M Phosa and Mr AT Meyer was subsequently read to and approved of by WGSC 4.

The meeting was closed at 16h50.
